About the Dashboard

USDA is investing in the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) and the WIC Farmers' Market Nutrition Program (FMNP) to reach more eligible families, keep families in WIC while they remain eligible, and encourage families to redeem more of their food benefits. The dashboard tracks the progress of this work.

Data Sources

This dashboard is based on several data sources:

Most project data under the Outreach, Shopping, Workforce, Technology, and Farmers' Markets focus areas are provided by the projects' points of contact. WIC Modernization Grant information is provided by WIC State agencies (SAs), and funding amounts for these grants are published on the FNA website: <https://www.fna.usda.gov/wic/modernization>.

Key Definitions

Some key data definitions include:

State Agency – WIC State agencies (SAs) include the health department or comparable agency of each of the fifty States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa, or the Commonwealth of the Northern Mariana Islands; an Indian tribe, band or group recognized by the Department of the

Interior; an intertribal council or group which is an authorized representative of Indian tribes, bands or groups recognized by the Department of the Interior and which has an ongoing relationship with such tribes, bands or groups for other purposes and has contracted with them to administer the Program; or the appropriate area office of the IHS. The projects within each project category refer to grants or subgrants ('projects') made directly to SAs working independently or, in some cases, SAs working in partnership with other SAs; WIC local agencies; or nonprofit organizations.

Cash-Value Benefit (CVB) – Cash-value voucher means a fixed-dollar amount check, voucher, electronic benefit transfer (EBT) card or other document which is used by a participant to obtain authorized fruits and vegetables. Cash-value voucher is also known as cash-value benefit (CVB) in an EBT environment.

Electronic Benefit Transfer (EBT) – A method of access to WIC food benefits (for example, a card or other access device approved by the USDA Secretary).
