SWRO Team,

Please consider this FNS' approval of Arizona's attached request to issue Emergency Allotments (EA) to all ongoing SNAP households in the State of Arizona.

This approval will allow the State to issue EA to ongoing SNAP households for April and May 2020, increasing their current monthly allotment up to the maximum monthly allotment for a household of that size. Households that receive zero benefits because their income is too high are not considered participating SNAP households for purposes of EA, and are therefore not entitled to EA. Households that receive zero benefits for their first month due to pro-ration and then receive SNAP benefits in subsequent months are considered SNAP recipients and are entitled to EA. The approval is for two months and any extension beyond that timeframe would require additional FNS approval. Ongoing SNAP households that already receive the maximum monthly allotment for their household size are not eligible for EA. All EA will be delivered on ongoing SNAP households' EBT cards.

Please ask the State to confirm receipt and REPLY ALL, upon notice of the State's confirmation of receipt. We would also ask the State to alert any contacts they may have in the retailer community of the emergency issuance and its timing, so stores can stock up in preparation.

Dear Mr. Crudup:

On March 13, 2020, President Trump declared a national emergency due to the novel coronavirus (COVID-19) outbreak. This is in addition to Arizona's Governor, Douglas Ducey's statewide Declaration of Emergency issued on March 11, 2020.

Federal and state guidance have directed agencies to take additional steps to prepare for, respond to, and mitigate the spread of COVID-19 for purposes of protecting the health and welfare of all individuals. This pandemic requires social distancing including schools, businesses and workplaces being shut down. While Arizona is at the forefront of using technology to process applications, including an easily accessible online application, the state's resources are being challenged to handle the volume of telephone interviews required to process an influx of Supplemental Nutrition Assistance Program (SNAP) applications. In addition, grocery stores are experiencing an increased demand for food items leaving many store shelves bare.

Enclosed is Arizona's Request to Provide Emergency Allotments (Supplements) to SNAP Households as outlined in H.R 6201, The Families First Coronavirus Response Act.

Adding to our need for responsible leadership and innovation during this time, Arizona is preparing a series of office closures. These closures are critical to ensuring the health and safety of our clients and staff; yet, will potentially add barriers to accessing our services. To mitigate these barriers, Arizona is requesting additional program flexibility during this time. In order to provide uninterrupted assistance to SNAP recipients, the Arizona Department of Economic Security, Family Assistance Administration is requesting your consideration of the enclosed SNAP waivers.

**Request to Waive Interview** - Waiving the interview during this pandemic will ensure Arizona is better prepared to respond and fulfill our agency's role to provide recovery to our community in a timely manner.

**Request to Extend Certification Periods** - Extending the certification periods as proposed via an automated process would ensure benefits will continue to be provided to households during this pandemic, reduce workload, and would be a more effective and efficient administration of the SNAP program.

**Request to Allow Hot Meals** - The need for hot food will remain critical through this pandemic as families experience a loss of income or care which could result in their way of life being disrupted such as decreased access to cooking facilities, hot meals and shelter.

**Request to Waive Student Criteria** - Currently eligible students are unable to meet the required 20 hours a week of employment due to business closures. The waiver will also ensure that currently eligible students will maintain their SNAP benefits when they report a change due to widespread business closures.

Your prompt attention to our request is appreciated. ## Request to Provide Emergency Allotments (Supplements) to SNAP Households

The contents of this document do not have the force and effect of law and are not meant to bind the public in any way. This document is intended only to provide clarity to the public regarding existing requirements under the law or agency policies.

### 4. Proposed Alternative Procedures:

The State proposes to provide an emergency allotment to address temporary food needs to households to bring all households up to the maximum benefit due to pandemic related economic conditions for up to 2 months. Contingent upon the availability of funding and ongoing need, USDA may approve additional months of emergency issuance with an extension request from the State.

These households are eligible for temporary emergency allotments because:

- There is a public health emergency declared by the Secretary of Health and Human Services and there is a State-wide emergency or disaster declaration (copy attached); and
- Due to Covid-19 [check all that apply]:
  - Residents of the State are confirmed to have contracted Covid-19
  - Some or all areas of the State are containment or quarantine zones

Arizona is proposing to waive all interviews for SNAP initial applications and recertifications including both telephonic and face-to-face interviews due to the coronavirus human pandemic. The state will continue to utilize electronic data sources when processing applications. The state will follow existing requirements in 7 CFR 273.2(c)(5) and 273.2(f) for obtaining additional verification from households when electronic data sources do not match or verify the information provided by the household on the application. Arizona proposes to waive the interview for 3 months effective upon the waiver submission date. Arizona will offer an in-person interview if requested on a case-by-case basis. Individuals will continue to be able to call the

Arizona Department of Economic Security, Family Assistance Administration to ask questions about their application.

Additionally, the extension will reduce the recertification-related workload for the next three months and will provide the State of Arizona flexibility in the administration of the SNAP program to mitigate future workload concerns that may arise as impacts from the pandemic progress and evolve.

9. **Caseload information, including percent of caseload and description of population expected to be affected by this waiver:** The estimated number of cases that would be extended under this proposal is approximately 30,000 cases per month for March 2020, April 2020, and May 2020. The current total statewide caseload as of February 2020, is 380,395.
10. **Anticipated impact on households and State agency operations:** This waiver will ensure current SNAP households continue to receive benefits and allow the State to more effectively use staff to timely process the influx of new applications and reviews resulting from federal and state pandemic guidance. Current SNAP recipients and new applicants will receive benefits timely and experience increased customer service and access to SNAP benefits.
11. **Anticipated implementation date and time period for which waiver is needed (please indicate if the waiver approval is needed to make system adjustments):** The waiver is requested for immediate implementation. Waiver approval is needed to make system adjustments for SNAP recertifications scheduled to end in March, April, and May 2020.



6. **Regulatory requirements:** Section 3(k)1) of the Food and Nutrition Act of 2008 and Federal regulation define “food” as “...any food or food product for home consumption except alcoholic beverages, tobacco, and hot foods or hot food products ready for immediate consumption...”
7. **Description of alternative procedures:** The state agency is requesting a waiver to allow hot foods and hot foods products prepared for immediate consumption to be considered “eligible foods” as long as they are purchased in FNS-authorized retail food stores in all counties with Arizona.
8. **Justification for request:** This waiver is requested under provision of 7 CFR 272.3(c)(1)(i) which allows the Food and Nutrition Service to authorize waivers due to extraordinary temporary situations, and 7 CFR 272.3(c)(1)(ii) which allows approval of waivers which result in a more effective and efficient administration of the SNAP program.

On March 13, 2020 President Trump declared a national emergency due to the novel coronavirus (COVID-19) outbreak. Additionally, Arizona’s governor, Douglas Ducey’s statewide Declaration of Emergency issued on March 11,2020 due to impacts of COVID-19. Federal and state guidance have directed agencies to take additional steps to prepare for, respond to, and mitigate the spread of COVID-19 for purposes of protecting the health and welfare of all individuals.

This pandemic requires social distancing including schools, businesses and workplaces being shut down. Waiving the Act and regulation language that excludes the purchase of hot foods and

hot food products prepared for immediate consumption will ensure that SNAP recipients most adversely affected by this pandemic have access to hot meals.

9. **Anticipated impact on households and State agency operations:** Allowing the purchase of hot foods will assist and provide critical relief to SNAP household most adversely affected including, but not limited to, elderly and disabled households, families with children home from school and those who experience a loss of income.

11. **Anticipated implementation date and time period for which waiver is needed:** Households in Arizona will be able to purchase hot foods and hot food products from FNS-authorized retailers from the approval date of this waiver until June 30, 2020.

3. **Regulatory citation:** 7 CFR 273.5(a); 273.5(b)

6. **Regulatory requirements:** The Supplemental Nutrition Assistance Program (SNAP) regulations at 7 CFR 273.5(a) state that an individual who is enrolled at least half-time in an institution of higher education shall be ineligible to participate in SNAP unless the individual qualifies for one of the exemptions contained in 7 CFR 273.5(b).
7. **Description of alternative procedures:** Arizona is requesting a waiver of regulations at 7 CFR 273.5(a) to allow students who are enrolled at least half-time in an institution of higher education to be eligible to participate in SNAP without being required to meet one of the exemptions in 7 CFR 273.5(b). The state agency will reevaluate for student eligibility at the next periodic report or eligibility review after the pandemic has ceased.
8. **Justification for request:** Because of the COVID-19 pandemic, many businesses, employers and school offices are closed. This makes it virtually impossible to verify if a student is enrolled in an institution of higher education, if the student is approved to participate in a work study program, or if a student is assigned to or placed in an institution of higher education through or in compliance with one of the programs identified in 7 CFR 273.5(b)(11)(i) through 273.5(b)(11)(iv). In addition, students who are eligible for SNAP are impacted by business closures and are unable to work the required 20 hours a week of employment mandated in 7 CFR 273.5(b)(5).
9. **Caseload information, including percent of caseload and description of population expected to be affected by this waiver:** The total statewide caseload as of February 2020 is 380,395. Although Arizona cannot quantify the percentage of recipients that this waiver might impact, it is expected that the number of existing eligible students will remain the same. The number of students who are currently not eligible, but may become eligible due to the waiver, is unknown.
10. **Anticipated impact on households and State agency operations:** The waiver will allow students to be eligible for SNAP without the requirement to meet an exemption in 7 CFR 273.5(b) or for the agency to verify if the student meets one of these exemptions. The waiver will also ensure that currently eligible students will

maintain their SNAP benefits when they report a change in employment as of March 11, 2020 due to widespread business closures.

The waiver is requested for immediate implementation effective upon approval, and through applications and recertifications processed through June 30, 2020.
