**SUBJECT:** Pandemic Electronic Benefits Transfer Program (P-EBT)  
Approval of Delaware's State Plan for Children in Child Care,  
School Year 2021-2022

The Families First Coronavirus Response Act (P.L. 116-127; the Act), as amended, authorized a temporary assistance program for households with certain SNAP-enrolled children in child care during the public health emergency declared on January 27, 2020. Pursuant to the authority granted under Section 1101 of the Act, FNS approves Delaware's enclosed plan to operate P-EBT for children in child care.

### **Summary of State's Plan**

The Delaware Division of Social Services and the Delaware Department of Education will issue P-EBT benefits through the State's Supplemental Nutrition Assistance Program (SNAP) EBT card system to households with eligible children. The State's plan for SNAP-enrolled children in child care covers the months of September 2021 through June 2022.

Children in child care are eligible for benefits if they are enrolled in SNAP and their child care facility is closed or operating with reduced attendance or hours, or if they live in the area of a school that is closed or operating with reduced attendance or hours. The State will use the best feasibly available data and USDA-approved simplifying assumptions to issue benefits in amounts that are tied as closely as possible to the number of days that eligible children do not receive a meal service through their covered child care facility.

At a minimum, the State will identify all children under age 6 who are enrolled in SNAP in the benefit month. The State will not issue child care benefits to any child for months after their SNAP enrollment ends. Finally, the State will ensure that children who receive a benefit through P-EBT's child care component do not also receive a benefit through P-EBT's school component for the same month.

In addition, Delaware will:

- identify SNAP-enrolled child under age 6,
- for each month from September through June, determine if there has been a statewide reduction in access to child care by comparing Child and Adult Care Food Program (CACFP) lunch claims since the start of SY 2021-2022 to the same months prior to the pandemic,

- issue an average monthly benefit to all eligible children statewide for the months of September through December using claims for September-December 2021 compared to September-December 2019,
- determine separate monthly benefit amounts for each of the months of January to June 2022, based on the reduction of CACFP lunch claims in those months compared to the pre-pandemic months of January-February 2020 and March-June 2019,
- apply the calculated reduction to the average number of instructional days for school children in the same months (18 days), times the daily benefit amount to determine the statewide monthly benefit amount,
- provide USDA with their tentative average benefit for confirmation prior to issuing benefits for any month,
- tentatively issue benefits for the months of September through December in a single issuance in May,
- tentatively issue benefits for the months of January and February in a single issuance in June,
- tentatively issue benefits for the month of March in July,
- tentatively issue benefits for the month of April in August,
- tentatively issue benefits for the month of May in September,
- tentatively issue benefits for the month of June in October,
- make corrective issuances as needed on an ongoing basis.

Finally, the State will identify risks for improper payments and ensure a high level of integrity.

#### **Estimated Caseload and Value of P-EBT Benefits**

The State will calculate monthly benefits for each eligible child in the household equal to the daily reimbursement for a free breakfast, lunch, and snack multiplied by the number of benefit days calculated as described in the State's plan.

Delaware estimates that it will issue \$5.5 million to approximately 15,800 SNAP-enrolled children in child care from September 2021 through June 2022.

#### **Release of Information**

Pursuant to Section 1101(e) of the Act, the Secretary hereby authorizes the release of the information necessary to carry out P-EBT in Delaware. Section 1101(e) of the Act states, "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

#### **Plan Timetable and Revisions**

Delaware will distribute benefits to households consistent with the timeframes identified in the State plan. Should the State encounter challenges or delays that significantly impair its ability to implement the approved P-EBT plan or require substantive changes, the State must notify the FNS Regional Office as soon as possible. The FNS Regional Office will work with the State to identify reasonable solutions and review revised plans for approval or further revision.

### **Civil Rights**

Delaware will continue to comply with civil rights requirements, to include providing equal access to individuals with disabilities and individuals who are limited English proficient.

### **Administrative Funds**

The Delaware Division of Social Services will participate in a P-EBT Administrative Budget Planning process using the FNS-366(a) Program and Budget Summary. When the FNS-366(a) is finalized, that will determine the State's Administrative Grant level. However, the FNS-366(a), Program and Budget Summary, may be updated and revised as the State's operational plan evolves.

### **Reporting**

The Delaware Division of Social Services will complete the FNS-292B, the FNS-46, the FNS-388, and the FNS-778 reports in accordance with existing requirements.

FNS appreciates Delaware's exceptional efforts to maintain children's access to nutritious meals, and understands that even as the nation recovers from this difficult time, State agencies and local program operators will still face any number of challenges.
