## Overview

The Special Supplemental Nutrition Program for Women, Infants and Children (WIC) provides breastfeeding promotion and support for pregnant and postpartum mothers. These services are an important component of the nutrition education benefits offered by the WIC Program to approximately 6 million people each month.

The Child Nutrition Act of 1966 requires the Department of Agriculture (USDA) to annually compile and publish breastfeeding performance measurements. This year's report is a compilation of fiscal year (FY) 2019 breastfeeding performance measurements, based on program participation data of the number of partially and fully breastfed infants for each WIC State and local agency. The USDA's Food and Nutrition Service uses this data to monitor breastfeeding trends and to identify exemplary performance of WIC State and local agencies.

The WIC Program has achieved many accomplishments in promoting and supporting breastfeeding, including improvement in the overall breastfeeding rate among WIC participants nationwide. Local WIC programs and staff, who provide education and support to mothers, are the key driver of this positive trend.

## **Definitions**

### **Infants**

Persons under one year of age.

### **Breastfeeding**

Practice of feeding a mother's breastmilk to her infant(s) on the average of at least once a day.

### **Breastfeeding Women**

Women up to one year postpartum who are breastfeeding their infants.

### **Fully Breastfed Infants**

Infants of participating breastfeeding women who do not receive infant formula from the WIC Program.

### **Partially Breastfed Infants**

Infants who are breastfed at least once a day and receive infant formula from the WIC Program.

### **Fully Formula-fed Infants**

Infants who are not fully or partially breastfed and receive infant formula from the WIC Program.

## **Data Sources**

The data used in this report was submitted by State agencies in April – June 2020 on behalf of local agencies. Due to timing differences and revised data submissions by State agencies, the data provided in this report may not match the data from State agency annual closeout reports (FNS-798/798A reports). The data contained in this report is as of the publication date. For consistent comparisons, data from State agency-submitted FNS-798 reports were used in this report when comparing FY 2019 data to data from previous years. FY 2019 data from State agency-submitted Breastfeeding Data Local Agency reports were used for all FY 2019 data summaries. In all map figures, Indian Tribal Organizations (ITO) were combined with their respective geographic State for display purposes. For Table 2, all State and local agencies with less than thirty participants were removed to protect participant confidentiality.

## **Data Summary**

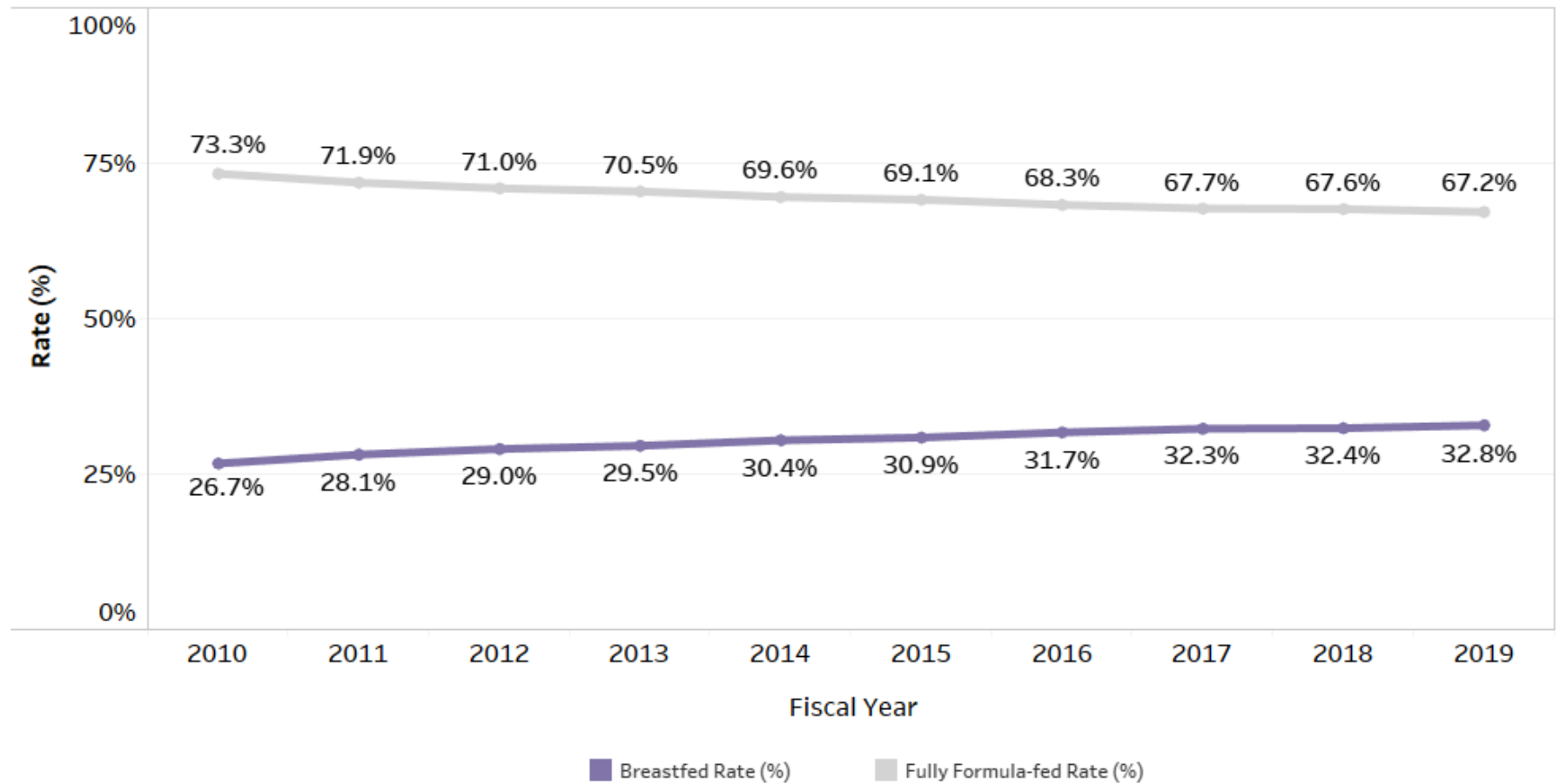
The percentage of breastfed infants has increased every year since FY 2010 (Figure 1; Table 1), reflecting the successful efforts of WIC State and local agencies to continue to provide quality breastfeeding services to WIC participants. Most State agencies saw an increase in the percentage of breastfed infants from FY 2010 to 2019, with a national increase of 6.15% and growth rate of 23.03%. The proportion of fully to partially breastfed infants averaged 40.44% to 59.56% between FY 2010 and 2019 (Figure 2).

In FY 2019, an average of 1.61 million infants were served by the WIC Program. Virgin Islands reported the highest breastfeeding percentage rate of all WIC State agencies at 58.21%, followed by Texas at 53.52% and Pueblo of Zuni at 47.30%. Pueblo of Zuni reported the highest fully breastfed percentage rate in FY 2019 at 35.14%, followed by Idaho at 33.18% and Vermont at 29.93% (Figure 3; Figure 4). Overall, the FY 2019 data showed a positive trend in the number of breastfed infants, reflecting the efforts of WIC State and local agencies that provide breastfeeding promotion and support and breastfeeding peer counseling services to WIC mothers.

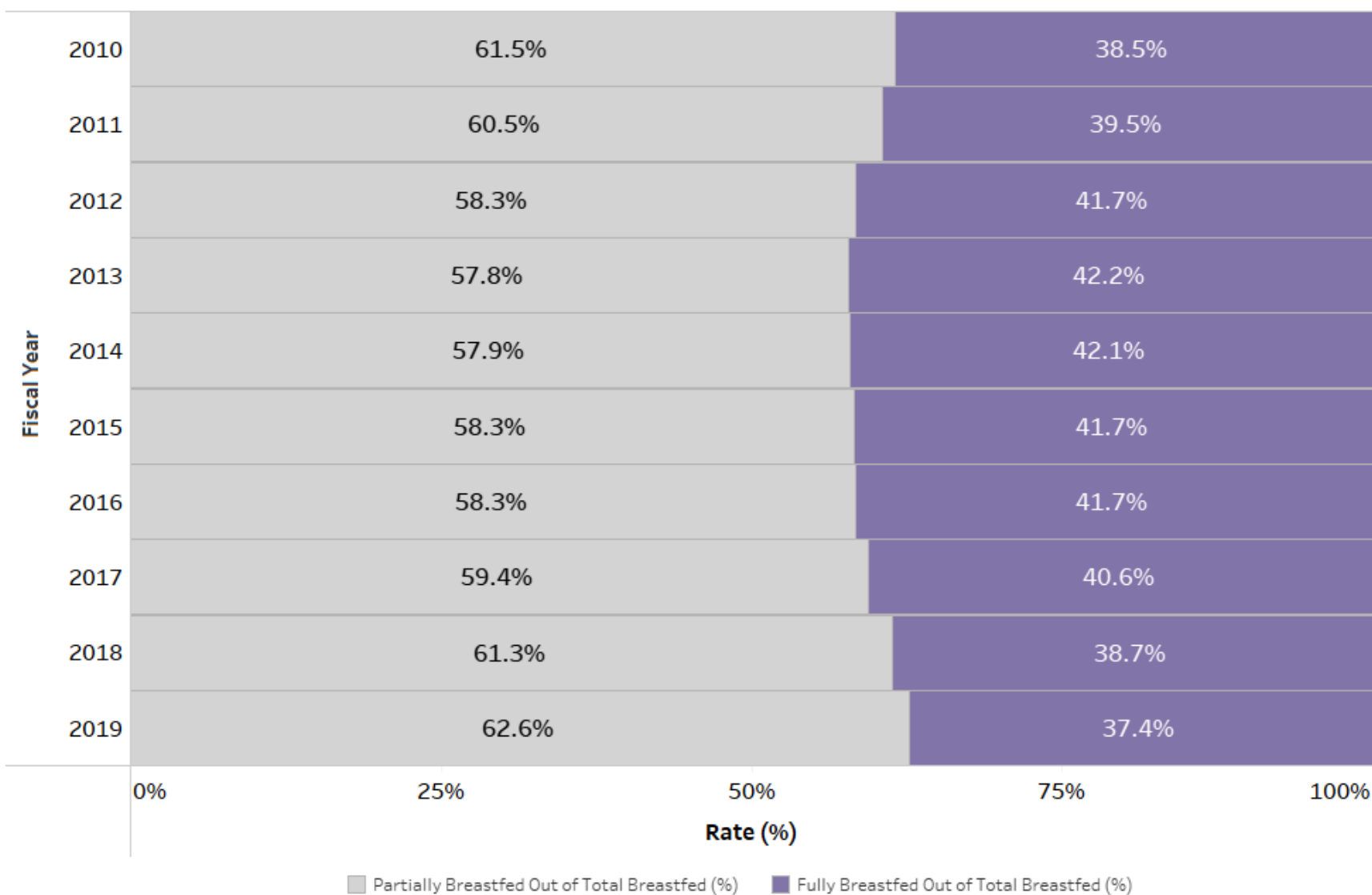

**Figure 2. National Proportion of Fully to Partially Breastfed Infants from FY 2010 to 2019.**

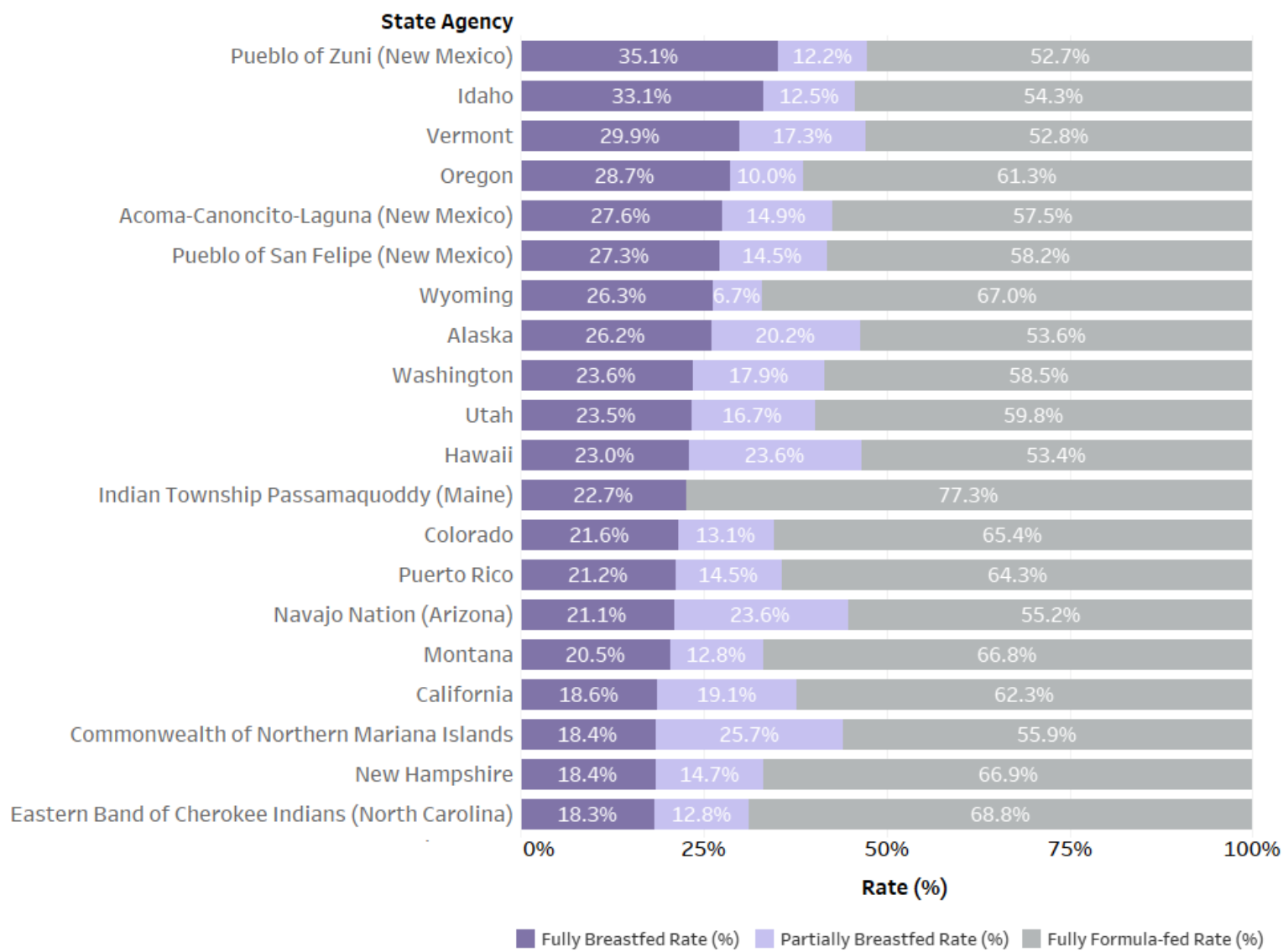
