SUBJECT: Pandemic Electronic Benefits Transfer Program (P-EBT)

Approval of New Hampshire's State Plan for Summer 2022,

School Children Only

The Families First Coronavirus Response Act (P.L. 116-127; the Act), as amended, authorized a temporary assistance program for households with children without access to meals in school and to certain SNAP-enrolled children in child care during the public health emergency declared in January, 2020. The March 11, 2021 American Rescue Plan Act (the ARP, P.L.117-2) extends P-EBT through the end of the public health emergency, a period that includes the summer of 2022.

Pursuant to the authority granted under Section 1101 of the Act, FNS approves New Hampshire's enclosed plan to issue P-EBT benefits to children in schools for the 2022 covered summer period.

Summary of State's Plan

The New Hampshire Department of Health and Human Services and the New Hampshire Department of Education will issue P-EBT benefits through the State's Supplemental Nutrition Assistance Program (SNAP) EBT card system to households with eligible children. In general, school children are eligible for benefits if they would have received free or reduced price meals at their schools through the National School Lunch Program (NSLP) if not for the closure or reduced attendance or hours of their schools. Children in child care are eligible if they are enrolled in SNAP and their child care facility is closed or operating with reduced attendance or hours, or if they live in the area of a school that is closed or operating with reduced attendance or hours. The ARP deems all schools closed for the 2022 P-EBT covered summer period.

Children in Schools

The State and its school districts will identify children who were eligible to receive free or reduced price NSLP meals as of the end of the school year 2021-2022. The State will offer households who become income-eligible for free or reduced price meals the ability to establish their eligibility during the 2022 covered summer period. In addition, the State and its school districts will identify eligible children through direct certification during the same period.

In addition, New Hampshire has or will:

- issue the U.S. standard benefit of \$391 to all eligible children,
- issue summer 2022 benefits to children who were approved for free or reduced price meals by application through October 2022:

- o a late application deadline is necessary to reach children whose families had no need to establish their eligibility for free or reduced price school meals or P-EBT for more than a year:
 - the state did not issue P-EBT benefits to school children during school year 2021-2022 and did not announce its summer 2022 plan to families until January 2023,
- the state will only issue summer 2022 benefits to the subset of these newly certified free or reduced price eligible children who were enrolled in New Hampshire schools at the end of school year 2021-2022,
- newly certified children who do not receive SNAP or other benefits administered by the Department of Health and Human Services (DHHS) will complete an additional P-EBT application to create an EBT profile with DHHS,
- tentatively issue a single benefit for the entire summer period in April 2023.

Finally, the state will identify risks for improper payments and ensure a high level of integrity.

Estimated Caseload and Value of P-EBT Benefits

New Hampshire estimates that it will issue \$12.9 million to approximately 33,000 school children during the 2022 covered summer period.

Release of Information

Pursuant to Section 1101(e) of the Act, the Secretary hereby authorizes the release of the information necessary to carry out P-EBT in New Hampshire. Section 1101(e) of the Act states, "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

Plan Timetable and Revisions

New Hampshire will distribute benefits to households consistent with the timeframes identified in the state plan. Should the state encounter challenges or delays that significantly impair its ability to implement the approved P-EBT plan or require substantive changes, the state must notify the FNS Regional Office as soon as possible. The FNS Regional Office will work with the state to identify reasonable solutions and review revised plans for approval or further revision.

Civil Rights

New Hampshire will continue to comply with civil rights requirements, to include providing equal access to individuals and individuals who are limited English proficient.

Administrative Funds

The New Hampshire Department of Health and Human Services will participate in a P-EBT Administrative Budget Planning process using the FNS-366(a) Program and Budget Summary. When the FNS-366(a) is finalized, that will determine the state's Administrative Grant level. However, the FNS-366(a), Program and Budget Summary, may be updated and revised as the state's operational plan evolves.

Reporting

The New Hampshire Department of Health and Human Services will complete the FNS-292B, the FNS-46, the FNS-388, and the FNS-778 reports in accordance with existing requirements.
