SUBJECT: Pandemic Electronic Benefits Transfer Program (P-EBT)

Approval of New Mexico's State Plan for Summer 2021

(school-age children only)

TO: Bill Ludwig

The Families First Coronavirus Response Act (P.L. 116-127; the Act), as amended, authorized a temporary assistance program for households with children without access to meals in school and to certain SNAP-enrolled children in child care during the public health emergency originally declared in January 2020. The March 11, 2021 American Rescue Plan Act (the ARP, P.L. 117-2) extends P-EBT through the end of the public health emergency, a period that includes the summer of 2021.

Pursuant to the authority granted under Section 1101 of the Act, FNS approves New Mexico's enclosed plan to issue P-EBT benefits to children in schools for the 2021 covered summer period. New Mexico will submit a separate summer P-EBT plan for children in child care.

Summary of State's Plan

The New Mexico Human Services Department and the New Mexico Public Education Department will issue P-EBT benefits through the State's Supplemental Nutrition Assistance Program (SNAP) EBT card system to households with eligible children. In general, school children are eligible for benefits if they would have received free or reduced price meals at their schools through the National School Lunch Program (NSLP) if not for the closure or reduced attendance or hours of their schools. The ARP deems all schools closed for the 2021 P-EBT covered summer period.

Children in Schools

The State and its school districts will identify the children who were eligible to receive free or reduced price NSLP meals as of the end of school year 2020-2021. The State will offer households who become income-eligible for free or reduced price meals the ability to establish their eligibility during the 2021 covered summer period. In addition, the State and its school districts will identify eligible children through direct certification during the same period.

In addition, New Mexico will:

- issue the U.S. standard benefit of \$375 to all eligible children,
- tentatively issue a single benefit for the entire summer period in August for children determined eligible by that date,

- set an application submission deadline of July 15 for households of children who become newly eligible during the covered summer period:
 - New Mexico SFAs will use their standard NSLP applications for summer P-EBT benefits,
 - o school districts will process these applications immediately after the end of the covered summer period,
 - the State will issue summer P-EBT benefits to these households upon approval of their applications.

Children in Child Care

The State will submit a separate summer P-EBT plan to USDA for children in child care at a future date.

Finally, the State will identify risks for improper payments and ensure a high level of integrity.

Estimated Caseload and Value of P-EBT Benefits

New Mexico estimates that it will issue \$100.0 million to approximately 266,500 school children during the 2021 covered summer period.

Release of Information

Pursuant to Section 1101(e) of the Act, the Secretary hereby authorizes the release of the information necessary to carry out P-EBT in New Mexico. Section 1101(e) of the Act states, "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

Plan Timetable and Revisions

New Mexico will distribute benefits to households consistent with the timeframes identified in the State plan. Should the State encounter challenges or delays that significantly impair its ability to implement the approved P-EBT plan or require substantive changes, the State must notify the FNS Regional Office as soon as possible. The FNS Regional Office will work with the State to identify reasonable solutions and review revised plans for approval or further revision.

Civil Rights

New Mexico will continue to comply with civil rights requirements, to include providing equal access to individuals with disabilities and individuals who are limited English proficient.

Administrative Funds

The New Mexico Human Services Department will participate in a P-EBT Administrative Budget Planning process using the FNS-366(a) Program and Budget

Summary. When the FNS-366(a) is finalized, that will determine the State's Administrative Grant level. However, the FNS-366(a), Program and Budget Summary, may be updated and revised as the State's operational plan evolves.

Reporting

The New Mexico Human Services Department will complete the FNS-292B, the FNS-46, the FNS-388, and the FNS-778 reports in accordance with existing requirements.
