**Isticmaalka Xaashida Macluumaadka**

Sharciga Qadada Dugsiga ee Qaran Richard B. Russell waxa uu nagu waajibinayaa in aanu i sticmaalno macluumaadkan arjiga si aanu u eego cida u qalanta cuntada bilaashka ah ama qimaha jaban. Waxa aanu kaliya ansixin doonaa foomamka dhamaystiran. Waxa aanu la wadaagi karnaa macluumaadka barnaamijyada waxbarashada, caafimaadka, iyo nafaqada si ay gacan uga gaystaan siirta gunooiyinka barnaamijka ee qoyska. Baadhayaasha iyo bilayska ayaa u isticmaali kara macluumaadka si ay u eegaan in shuruucda barnaamijka la buuxiyay.

Fadlan waxa aad bixisa farta lambarka ee ugu danbeeya lambarka Sooshaal Sekuuritiga ee xubinta qofka wayn ee qoyska ee saxeexaysa arjiga. Hadii qofka wayn aanu haysan, 'Sax hadii aanu lahayn lambarka Sooshaal Sekuuritiga' Dalbaha Foster Child loogama baahna inuu ku qoro lambarka Sooshaal Sekuuritiga. Arjiyada caruurga qoyska ee qaadata SNAP ama TANF ama FDPIR loogama baahna inay ku qoraan lambarka Sooshaal Sekuuritiga. Caruurga qaar ayaa u qalma cuntada bilaashka ah iyada oo aan dalban.
