SUBJECT: Pandemic Electronic Benefits Transfer Program (P-EBT)

Approval of South Carolina's State Plan for Summer 2021

(school-age children only)

The Families First Coronavirus Response Act (P.L. 116-127; the Act), as amended, authorized a temporary assistance program for households with children without access to meals in school and to certain SNAP-enrolled children in child care during the public health emergency originally declared in January 2020. The March 11, 2021 American Rescue Plan Act (the ARP, P.L. 117-2) extends P-EBT through the end of the public health emergency, a period that includes the summer of 2021.

Pursuant to the authority granted under Section 1101 of the Act, FNS approves South Carolina's enclosed plan to issue P-EBT benefits to children in schools for the 2021 covered summer period. (South Carolina will submit a separate summer P-EBT plan for children in child care.)

# **Summary of State's Plan**

The South Carolina Department of Social Services and the South Carolina Department of Education will issue P-EBT benefits through the State's Supplemental Nutrition Assistance Program (SNAP) EBT card system to households with eligible children. In general, school children are eligible for benefits if they would have received free or reduced price meals at their schools through the National School Lunch Program (NSLP) if not for the closure or reduced attendance or hours of their schools. The ARP deems all schools closed for the 2021 P-EBT covered summer period.

### **Children in Schools**

The State and its school districts will identify the children who were eligible to receive free or reduced price NSLP meals as of the end of school year 2020-2021. The State will offer households who become income-eligible for free or reduced price meals the ability to establish their eligibility during the 2021 covered summer period. In addition, the State and its school districts will identify eligible children through direct certification during the same period.

In addition, South Carolina will:

- issue the U.S. standard benefit of \$375 to all eligible children,
- issue benefit for the entire summer period in a maximum of two issuance cycles:
  - o tentatively issue a partial benefit in early to mid-August,

- o tentatively issue the remaining summer benefit on September 30,
- set an application submission deadline of August 16 for households of children who become newly eligible during the covered summer period:
  - South Carolina SFAs will use their standard NSLP applications for summer P-EBT benefits,
  - o school districts will process these applications immediately after the end of the covered summer period,
  - o the State will tentatively issue summer P-EBT benefits to these households on September 30.

#### **Children in Child Care**

The State will submit a separate summer P-EBT plan to USDA for children in child care at a future date.

Finally, the State will identify risks for improper payments and ensure a high level of integrity.

#### **Estimated Caseload and Value of P-EBT Benefits**

South Carolina estimates that it will issue \$162.5 million to approximately 433,000 school children during the 2021 covered summer period.

#### Release of Information

Pursuant to Section 1101(e) of the Act, the Secretary hereby authorizes the release of the information necessary to carry out P-EBT in South Carolina. Section 1101(e) of the Act states, "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

### **Plan Timetable and Revisions**

South Carolina will distribute benefits to households consistent with the timeframes identified in the State plan. Should the State encounter challenges or delays that significantly impair its ability to implement the approved P-EBT plan or require substantive changes, the State must notify the FNS Regional Office as soon as possible. The FNS Regional Office will work with the State to identify reasonable solutions and review revised plans for approval or further revision.

### **Civil Rights**

South Carolina will continue to comply with civil rights requirements, to include providing equal access to individuals with disabilities and individuals who are limited English proficient.

## **Administrative Funds**

The South Carolina Department of Social Services will participate in a P-EBT Administrative Budget Planning process using the FNS-366(a) Program and Budget Summary. When the FNS-366(a) is finalized, that will determine the State's Administrative Grant level. However, the FNS-366(a), Program and Budget Summary, may be updated and revised as the State's operational plan evolves.

# Reporting

The South Carolina Department of Social Services will complete the FNS-292B, the FNS-46, the FNS-388, and the FNS-778 reports in accordance with existing requirements.
