AMENDMENT TO VI DHS AGENCY DECLARATION DECLARING A STATE OF EMERGENCY IN RESPONSE TO THE COVID-19 CORONAVIRUS PANDEMIC IN THE UNITED STATES VIRGIN ISLANDS

WHEREAS, on March 13, 2020, the Governor Albert Bryan Jr. issued the Executive Order and Proclamation Declaring a State of Emergency in response to the Covid 19-CoronaVirus Pandemic (Declarations of a State of Emergency), and the Government has been coordinating the Territories' response and enforcing protective actions to address'' COVID-19, a public health, safety, and welfare of residents and visitors located in the Virgin Islands

WHEREAS, approximately 21287 persons have been known to contract the coronavirus and have been identified in the United States Virgin Islands and 120 have died;

WHEREAS, the Department administers programs and supports to the Territories most vulnerable citizens and collaborates with community and health partners to meet the challenges posed by COVID-19 Virus;

WHEREAS, despite the progress that is continuing to be made by the Territory and there is a vaccine available to prevent the COVID virus, COVID 19 continues to be a public health risk and Virgin Islands residents continue to contract the Virus;

WHEAREAS, in addition to liability protections, the state of emergency allows for the Department of Human Services and the United States Virgin Islands to continue to take part in and offer all flexibilities allowable under Federal and Territory law related to the COVID-19 pandemic that benefit or provide relief to the residents of the Territory;

THEREFORE, I, Commissioner Kimberley Causey Gomez, in consultation and with concurrence of the Honorable, Governor Albert Bryan Jr. hereby amend the VI DHS Agency Declaration to Extend the State of Emergency made on July 20, 2022 and extend the state of emergency that continues to exist throughout the United States Virgin Islands for the purposes of responding to COVID 19 effective through the Federal expiration date.
