22314SUBJECT: Pandemic Electronic Benefits Transfer Program (P-EBT)
Approval of West Virginia's State Plan for School Children,
School Year 2021-2022TO:Dr. Patty Bennett
Regional Administrator
Mid-Atlantic Regional Office

The Families First Coronavirus Response Act (P.L. 116-127; the Act), as amended, authorized a temporary assistance program for households with children without access to meals in school and to certain SNAP-enrolled children in child care during the public health emergency declared on January 27, 2020. Pursuant to the authority granted under Section 1101 of the Act, FNS approves West Virginia's enclosed plan to operate P-EBT for school children.

Summary of State's Plan

The West Virginia Department of Health and Human Resources and the West Virginia Department of Education will issue P-EBT benefits through the State's Supplemental Nutrition Assistance Program (SNAP) EBT card system to households with eligible children. The State's plan for school children covers the months of August 2021 through May 2022.

School children are eligible for benefits if they would have received free or reduced price meals at their schools through the National School Lunch Program (NSLP) if not for the closure or reduced attendance or hours of their schools for a period of at least 5 consecutive days. The State will use the best feasibly available data and USDA-approved simplifying assumptions to issue benefits in amounts that are tied as closely as possible to the number of days that eligible children do not receive a meal service at school.

The State and its school districts will identify children eligible for free or reduced price NSLP meals using the most current available data. All school districts that rely on eligibility data from the most recent prior year will have a means to address that they do not issue benefits to school year 2020-2021 graduates and other non-students, and will offer households with new students the ability to establish their eligibility through the traditional school food authority-run school meal application and direct certification processes.

In addition, West Virginia will:

• tentatively issue benefits for the months of August through December in a single distribution on April 11,

- tentatively issue benefits for the months of April and May as well as any corrective issuances for the previous issuance in a single distribution on July 22,
- tentatively issue any final corrections on September 29,
- use current school year free and reduced price eligibility lists to identify students who may qualify for P-EBT benefits:
 - newly eligible households that submit applications during the State's two week application period will be considered eligible back to the beginning of the school year,
 - newly eligible households that submit applications after the State's application period will be considered eligible from the date of their eligibility determination forward,
- calculate benefits for each income-eligible student based on the student's number of eligible virtual learning days and COVID-related absences; the State will use a tiered benefit:
 - children with 1-5 days of virtual learning or absences due to COVID in a month will receive benefits equal to 3 days of meal benefits,
 - children with 6-15 days of virtual learning or absences due to COVID in a month will receive benefits equal to 10 days of meal benefits,
 - children with fully virtual schedules and other children with more than 16 days of virtual learning or absences due to COVID in a month will receive benefits equal to 18 days of meal benefits,
- provide guidance to schools detailing the requirements for:
 - determining school eligibility based on school closures or reductions in attendance and hours,
 - o determining what is a COVID-related absence and,
 - o determining the number of benefit days for individual students.

Finally, the State will identify risks for improper payments and ensure a high level of integrity.

Estimated Caseload and Value of P-EBT Benefits

The State will calculate monthly benefits for each eligible child in the household equal to the daily reimbursement for a free breakfast, lunch, and snack multiplied by the number of benefit days calculated as described in the State's plan.

West Virginia estimates that it will issue \$82.4 million to approximately 116,100 children for school closures and reductions in attendance and hours extending from August 2021 through May 2022.

Release of Information

Pursuant to Section 1101(e) of the Act, the Secretary hereby authorizes the release of the information necessary to carry out P-EBT in West Virginia. Section 1101(e) of

the Act states, "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

Plan Timetable and Revisions

West Virginia will distribute benefits to households consistent with the timeframes identified in the State plan. Should the State encounter challenges or delays that significantly impair its ability to implement the approved P-EBT plan or require substantive changes, the State must notify the FNS Regional Office as soon as possible. The FNS Regional Office will work with the State to identify reasonable solutions and review revised plans for approval or further revision.

Civil Rights

West Virginia will continue to comply with civil rights requirements, to include providing equal access to individuals with disabilities and individuals who are limited English proficient.

Administrative Funds

The West Virginia Department of Health and Human Resources will participate in a P-EBT Administrative Budget Planning process using the FNS-366(a) Program and Budget Summary. When the FNS-366(a) is finalized, that will determine the State's Administrative Grant level. However, the FNS-366(a), Program and Budget Summary, may be updated and revised as the State's operational plan evolves.

Reporting

The West Virginia Department of Health and Human Resources will complete the FNS-292B, the FNS-46, the FNS-388, and the FNS-778 reports in accordance with existing requirements.

FNS appreciates West Virginia's exceptional efforts to maintain children's access to nutritious meals, and understands that even as the nation recovers from this difficult time, State agencies and local program operators will still face any number of challenges.
