SUBJECT: Fiscal Year (FY) 2026 Food and Administrative Funding for The Emergency Food Assistance Program (TEFAP)

TO: Regional Directors
Supplemental Nutrition Programs

State Directors
TEFAP State Agencies

Introduction

Five pieces of legislation currently govern the level of food and administrative funding available to TEFAP in fiscal year (FY) 2026:

- The Agriculture Improvement Act of 2018 (P.L. 115-334, the 2018 Farm Bill);
- The Food and Nutrition Act of 2008 (P.L. 88-525, as amended);
- The Emergency Food Assistance Act of 1983 (P.L. 98-8, as amended);
- The Consolidated Appropriations Act, 2025 (P.L. 119-4, as amended);
- Continuing Appropriations Act, 2026 (P.L. 119-37).

Food Funds

Section 27(a) of the Food and Nutrition Act of 2008 established the amount of funding available for TEFAP food purchases for FY 2009, and indexes that amount to annual changes in the Thrifty Food Plan (TFP). Section 4018 of the Agriculture Improvement Act of 2018 (2018 Farm Bill) maintained the funding formula established in Section

27(a) of the Act. The 2018 Farm Bill also added specified amounts annually, separate and distinct from the inflationary adjustments referenced above.

Based on changes in the TFP and the additional funds authorized by the 2018 Farm Bill, the amount available for TEFAP food purchases through the FY 2026 Appropriations Act is \$471.5 million. Of this, \$6.3 million is needed to pay costs associated with ordering and transporting food, leaving \$465.2 million for the purchase of food. Additionally, \$94.3 million is available for State agencies to convert to administrative funds.

Carryover of State TEFAP Food Entitlement

Additionally, Section 27(a) of the Food and Nutrition Act of 2008 allows funds authorized for the purchase of TEFAP food to remain available for two fiscal years, subject to such terms and conditions as determined by USDA. Therefore, States may keep any remaining TEFAP food entitlement balance at the end of the first fiscal year and place orders against it during the subsequent fiscal year. However, funds remaining at the end of the second fiscal year after which they were initially appropriated will no longer be available to USDA and will be unavailable for States to place orders against. Any remaining State balance of FY 2025 TEFAP food entitlement will expire at the end of FY 2026 (September 30, 2026). State agencies should ensure that any carryover FY 2025 food entitlement balance is expended by September 30, 2026.

Conversion of Food Funds to Administrative Funds

TEFAP State agencies may convert their fair-share of up to 20 percent of their entitlement food funds into TEFAP administrative funds (P.L.119-37, the Continuing Appropriations Act, 2026). Accordingly, \$94.3 million in FY 2026 TEFAP entitlement food funds are available for conversion into TEFAP administrative funds. The total

available for each State agency to convert is listed on *Worksheet #2 – FY 2026 TEFAP Food*, in Column H.

FNS National Office must be informed by February 20, 2026, whether TEFAP State agencies want to accept their portion of the convertible funds as food funds, administrative funds, or any combination of the two. State agencies should only convert the amount of funds they are able to obligate by September 30, 2026.

Conversion of Administrative Funds to Food Funds

The Continuing Appropriations Act, 2026 (P.L. 119-37), includes \$80 million in TEFAP administrative funds.

As always, TEFAP State agencies may convert any portion of their administrative funds into food funds. FNS Headquarters must be informed by February 20, 2026, regarding what portion, if any, of their administrative funds TEFAP State agencies wish to convert to food funds.

In FY 2026, TEFAP State agencies should carefully consider the amount of administrative funding available in making conversion decisions. States should only convert an amount of administrative funds to food funds that they are able to obligate by September 30, 2026.

FY 2026 Entitlement and Administrative Funding Worksheets

Attached, please find the FY 2026 food and administrative funding worksheets that provide further details regarding FY 2026 TEFAP funding.

Worksheet #1 shows each State's share of the \$80 million in FY 2026 TEFAP administrative funds. TEFAP administrative funding was provided on November 14, 2025.

Worksheet #2 shows each State's allocation of FY 2026 TEFAP food funds provided in the Food and Nutrition Act that are *not convertible* to administrative funds, each State's *share of convertible funds*, each State's FY 2025 *carryover balance* of entitlement foods available in FY 2026, and the *total* of these amounts. Each State's FY 2025 entitlement carryover balance available in FY 2026 was determined based on an entitlement summary report pulled from the Web-Based Supply Chain Management system (WBSCM).

Conclusion

To review, FNS Headquarters must be informed whether TEFAP State agencies want to (a) accept their remaining portion of the \$94.3 million in convertible TEFAP food funds as food funds, administrative funds, or some combination of the two by February 20, 2026; and (b) convert any portion of their administrative funds into food funds by February 20, 2026. Regional Office staff will provide further guidance on applicable timeframes for submission to their offices, which will enable them to provide the information to FNS Headquarters in a timely manner.
