RE: SNAP –Nevada Request to Waive Able-Bodied Adults without Dependents Time
Limit – Approval

Dear Mr. Fisher:

This is in response to the Nevada State agency's request to waive the Supplemental Nutrition Assistance Program (SNAP) time limit for able-bodied adults without dependents throughout the State from June 1, 2016 through December 31, 2017.

The State agency's request meets the requirements for approval provided at 7 CFR 273.24(f) and relevant Food and Nutrition Service (FNS) guidance. Therefore, FNS is approving Nevada to waive the time limit Statewide for the requested 19-month period. The approval extends waiver number 2150026. The attached waiver response explains the supporting evidence used and the conditions of approval. Please note that based upon the 36-month data set provided, Nevada is eligible to implement the waiver for a 24-month period, through May 2018. If the State agency elects to continue the waiver for the full 24-month period, it must notify FNS. If you have any questions, please contact Shahdy Monemzadeh at shahdy.monemzadeh@fns.usda.gov.

WAIVER RESPONSE

1. **Waiver serial number:** 2150026
2. **Type of request:** Extension
3. **Statutory citation:** Section 6(o) of the Food and Nutrition Act of 2008, as amended
4. **Regulatory Citation:** 7 CFR 273.24
5. **State:** Nevada
6. **Region:** Western
7. **Regulatory requirement:** Section 6(o) of the Food and Nutrition Act of 2008, as amended, provides that no able-bodied adult without dependents (ABAWD) shall be eligible to participate in the Supplemental Nutrition Assistance Program (SNAP) as a member of any household if the individual received program benefits for more than 3 months during any 3-year period in which the individual was subject to but did not comply with the ABAWD work requirement. Section 6(o) also provides that, upon the request of the State agency, the Secretary may waive the applicability of the 3-month ABAWD time limit for any group of individuals in the State if the Secretary makes a determination that the area in which the individuals reside has an unemployment rate of over 10 percent, or does not have a sufficient number of jobs to provide employment for the individuals.
8. **Proposed alternative procedures:** The Nevada State agency has requested to waive the ABAWD time limit throughout the State from June 1, 2016 through December 31, 2017.

The State agency has supported its request based upon Nevada having an average unemployment rate 20 percent above the national average for the 36-month period of April 2013 through March 2016. During this time period the national average unemployment rate was 6.0 percent; 20 percent above that rate is 7.2 percent. As detailed in the following table, Nevada's average unemployment rate for the selected time period reached 7.7 percent.

- 9. Action and reason for approval or denial:** The Food and Nutrition Service (FNS) is approving the Nevada State agency's request to waive the ABAWD time limit Statewide because the State meets the requirements for approval provided at 7 CFR 273.24(f) and relevant FNS guidance.
- 10. Regulatory or legislative basis for action:** The waiver is approved pursuant to Section 6(o) of the Food and Nutrition Act of 2008, as amended and 7 CFR 273.24(f).
- 11. Information required for an extension:** To receive an amendment or extension the State agency must provide FNS with a formal request supported by data or other information as described in 7 CFR 273.24(f). Any request based upon unemployment rates must include data spreadsheets as supporting documentation.
- 12. Implementation date and expiration date:** The waiver is effective June 1, 2016, through December 31, 2017.
- 13. Limitation, if any, on regional office approval of like requests:** The waiver is limited to the Nevada State agency.
