Glossary A quick review of key terms before we get to the survey:

USDA-supported Summer Meals Programs include the Summer Food Service Program (SFSP) and the Seamless Summer Option (SSO) of the National School Lunch Program. Your State or organization may refer to them by another name.

**Congregate** meal service refers to meals that are served in a group setting, where participants eat the meal on-site.

**Non-congregate** meal service refers to the distribution of meals to participants so that the meals can be eaten off-site.

**Open enrollment sites** include area-eligible sites. These are meal service sites that do not require children to enroll in the program to receive meals.

**Non-congregate meal service models** refers to the way your organization ran your non-congregate sites, including participant enrollment, meal preparation, meal distribution, and site selection.

Meal pick-up refers to the distribution of non-congregate meals from a single location, such as grab 'n' go.

**Meal delivery** refers to the distribution of non-congregate meals through delivery to participants' homes. Some States did not allow meal delivery in Summer 2023.

**Multi-day meal issuance** refers to the practice of distributing multiple days-worth of meals to participants at one time. A few States did not allow multi-day meal issuance in Summer 2023.

**Bulk foods** are food items that contain multiple servings of food (half a gallon of milk vs 8 half-pints). Bulk food distribution was not allowed in several States in Summer 2023.
