Dear Secretary Hatch:

On December 11, 2025, the Florida Department of Children and Families requested to modify the State agency's Supplemental Nutrition Assistance Program (SNAP) Food Restriction Waiver implementation date from January 1, 2026, to April 20, 2026.

The Food and Nutrition Service (FNS) approves this modification request. As expressed in the State agency's request letter, this modification is intended to provide necessary additional time to prepare for implementation. Postponing implementation to April 20, 2026, will prevent inconsistent implementation amongst retailers and provide a stronger foundation for success.

This approval is for 2 years, from April 20, 2026, through April 19, 2028. FNS provides an adjusted project reporting schedule in the enclosure. All other terms and conditions of FNS's August 4, 2025, approval remain applicable.

FNS applauds Florida and its SNAP team for the significant efforts you have made towards implementation of your SNAP Food Restriction Waiver thus far. We look forward to continuing to support your efforts to successfully implement this innovative and impactful project on April 20, 2026.
