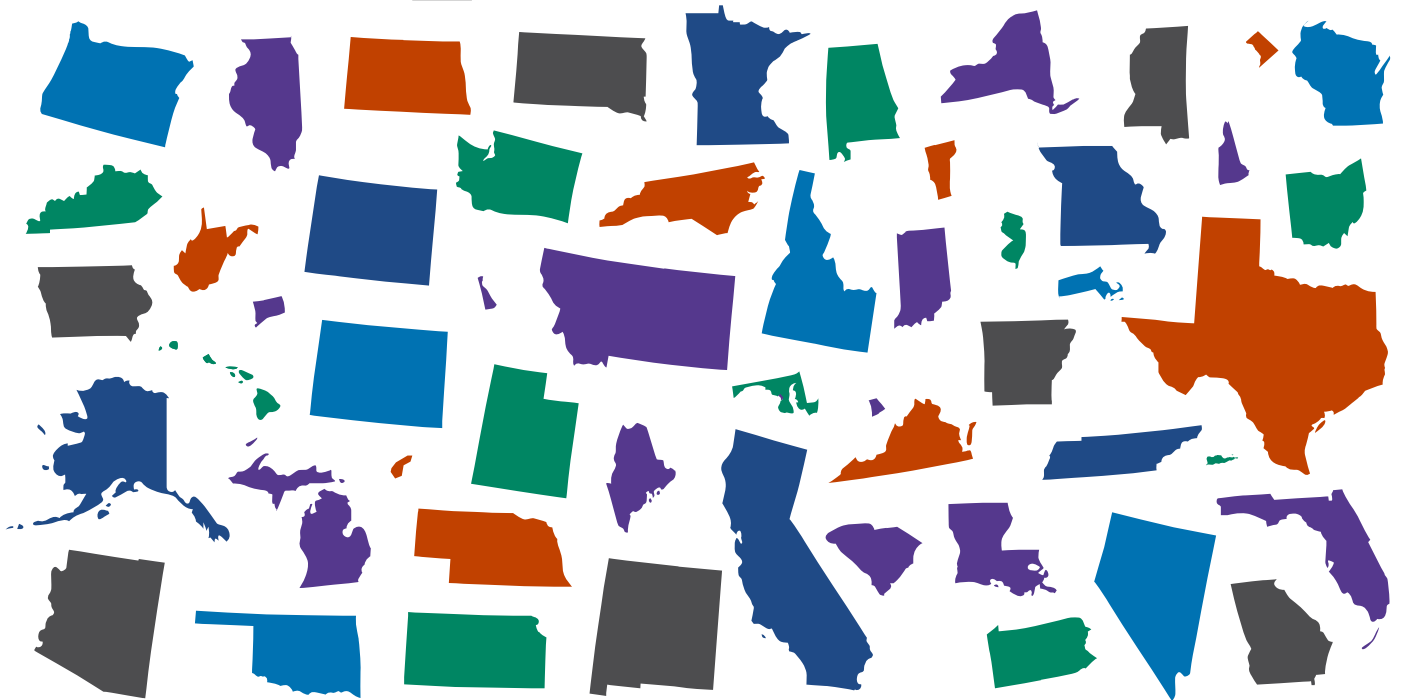

Introduction

Welcome to the 17th edition of the *Supplemental Nutrition Assistance Program (SNAP) State Options Report*.

SNAP statutes, regulations, and FNS waiver authority provide State agencies with the ability to adapt the program to best meet the needs of eligible households in their jurisdictions. State agencies may implement certain options and waivers within specific geographical areas or for specific populations if the State agency's implementation choices comply with Federal civil rights laws and are applied consistently. These policy options, demonstration projects, waivers, and administrative choices help State agencies simplify program administration and operations while promoting priorities such as program access, customer service, effective stewardship of Government resources, and program integrity.

This report summarizes 28 SNAP options, demonstration projects, and waivers and categorizes the 53 SNAP State agencies according to the options, demonstration projects, and waivers they have or have not implemented as of October 1, 2024. SNAP State agencies include all 50 States, the District of Columbia, Guam, and the Virgin Islands. The Food and Nutrition Service (FNS) and Westat developed this report using extant data from the Federal fiscal year (FFY) 2025 SNAP State Plans of Operation, FNS-approved demonstration projects and waivers, and a review of State legislation and policy.

This report compiles a selection of SNAP options, demonstration projects, and waivers State agencies have adopted and enables State agencies to identify opportunities to consult with and learn from one another. This report does not include all SNAP options, demonstration projects, and waivers State agencies have adopted.

This report has three parts:

- The **Statutory and Regulatory Citations** reference section provides statutory and regulatory citations for each option, demonstration project, and waiver. This section guides the reader to relevant provisions of the Food and Nutrition Act of 2008 and Title 7 of the Code of Federal Regulations.
- The **SNAP Option Profiles** section describes each option, demonstration project, and waiver. This section describes the choices within each option and displays a map or a chart of the State agencies that have selected the option, demonstration project, or waiver.
- The **SNAP State Agency Profiles** section provides a State-by-State summary of the options, demonstration projects, and waivers for each State agency.

This edition of the report includes several changes from previous editions. Ten new options and waivers have been added, and several option titles and descriptions from previous editions have been revised to communicate the different aspects of the options more clearly. Finally, options have been grouped into categories and listed alphabetically within groups.

Some options may require State agencies to receive waivers or notify FNS before implementation. State agencies should contact their Regional Office for guidance.

Policy and Operational Options

SNAP statutes and regulations grant State agencies discretion over certain program administration requirements. This flexibility enables State agencies to tailor the program to better meet the needs of eligible households within their jurisdictions.

This section highlights several policy and operational options related to SNAP eligibility, benefit determinations, and administration that State agencies may choose to implement. These options may require State agencies to notify FNS before implementation. State agencies should contact their Regional Office for guidance.

ABAWD Discretionary Exemptions

Section 6(o)(6) | 273.24(g)

An able-bodied adult without dependents (ABAWD) is a person aged 18–54 who does not meet any of the exemption criteria set by Federal law. People are not considered an ABAWD if they are exempt from the SNAP general work requirements, share a SNAP household with a person younger than 18, are pregnant, are experiencing homelessness, are a veteran, or are younger than 25 *and* were in foster care at 18 (or a higher age if the State offers extended foster care). ABAWDs must work and/or participate in a work program at least 80 hours per month, or participate in workfare, to receive SNAP benefits for more than 3 months in a 3-year period. The law provides each State agency with a limited number of discretionary exemptions. State agencies can use these exemptions to extend SNAP eligibility for individual ABAWDs on a monthly basis. Some agencies choose to use discretionary exemptions, while others do not. The data displayed are based on State agencies’ use of discretionary exemptions in FFY 2024.

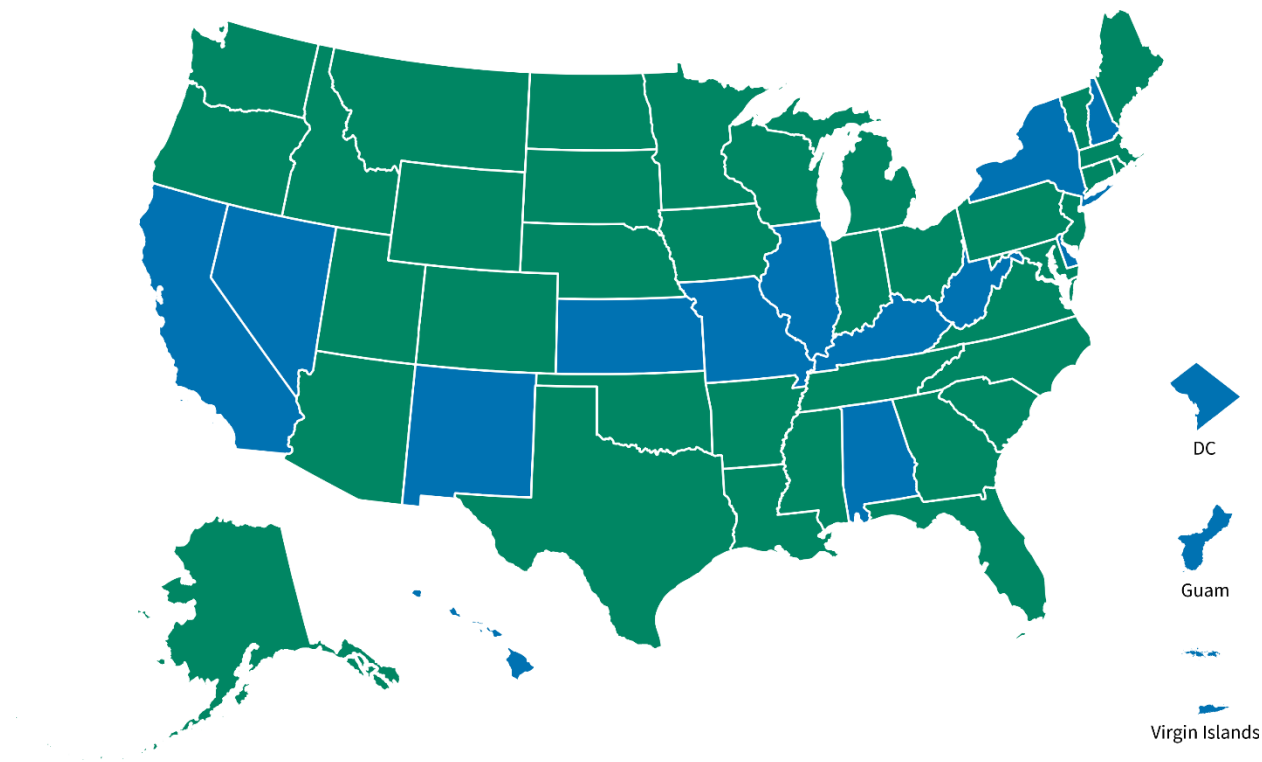

Broad-Based Categorical Eligibility

Section 5(a) | 273.2(j)(2)(ii)

By law, households that receive cash benefits from another means-tested program—such as Supplemental Security Income (SSI), Temporary Assistance for Needy Families (TANF), or General Assistance—are categorically eligible for SNAP. State agencies also have the option of adopting broad-based categorical eligibility (BBCE), which expands categorical eligibility to households that receive noncash benefits funded by TANF or Maintenance of Effort funds. Under BBCE, State agencies may align their asset and gross income limits with those used by the relevant TANF noncash benefit program that confers categorical eligibility. BBCE households must still meet all other SNAP rules to be eligible.

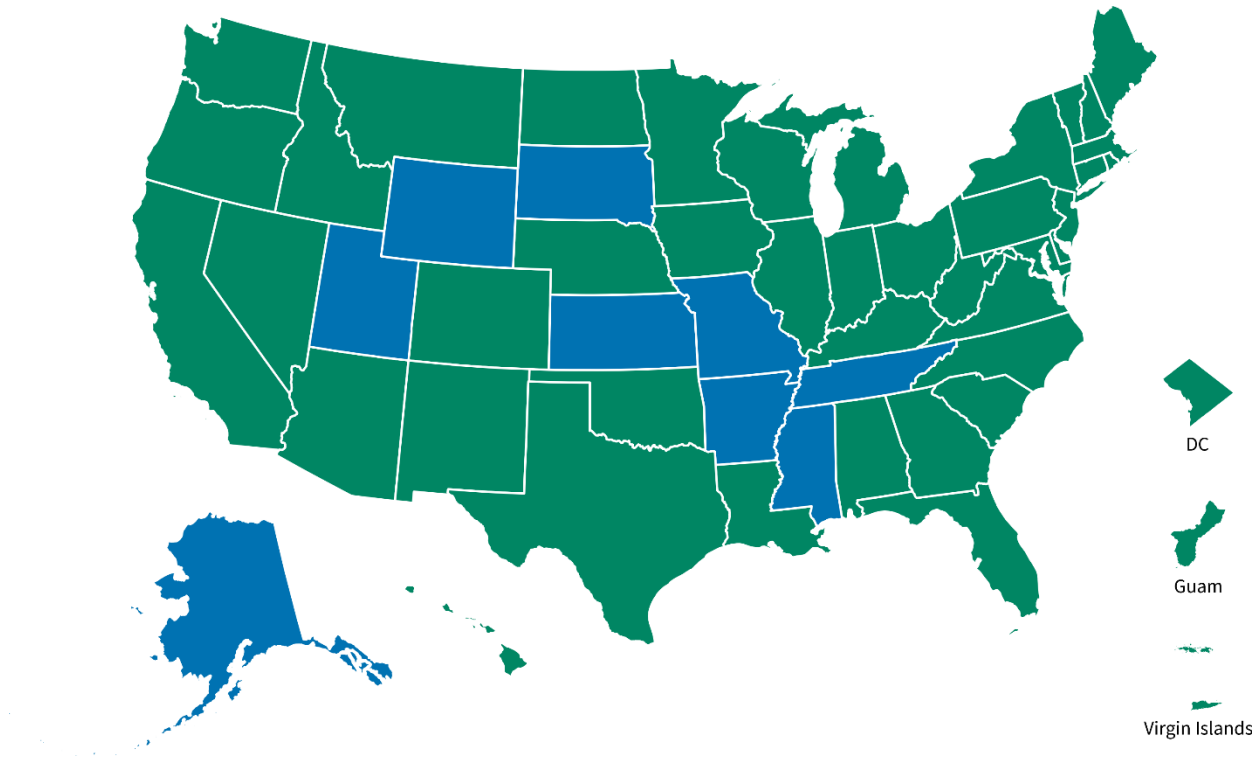

Certification Period Lengths

Section 3(f) | 273.10(f) | 273.12(a)(5)

State agencies have flexibility in how long they certify SNAP households, within certain limits and dependent on household circumstances. State agencies may certify households in which all adult members are 60 or older or have disabilities for a maximum of 24 months and all other households for a maximum of 12 months. Some State agencies certify nearly all households for the same length of time, while others certify households for varying lengths of time according to household circumstances. When the certification period nears its end date, households may reapply to participate, and, if they are eligible, the State agency will certify them for another certification period.

The following table illustrates the most common certification period lengths of 4, 6, 12, and 24 months. Some State agencies may certify households for different periods than those listed depending on household circumstances. The table does not include certification period lengths assigned under the Elderly Simplified Application Project (ESAP) or transitional benefits alternative (TBA); see those SNAP Option Profiles for more information.

Child Support–Related Disqualifications

Section 6(l)–(n) | 273.11(o) | 273.11(p) | 273.11(q)

State agencies have the option to disqualify household members who fail to cooperate with child support enforcement agencies without good cause. Under this option, State agencies may choose to apply the disqualification to custodial parents, noncustodial parents, or both custodial and noncustodial parents. State agencies also have the option to disqualify household members who are in arrears with court-ordered child support payments.

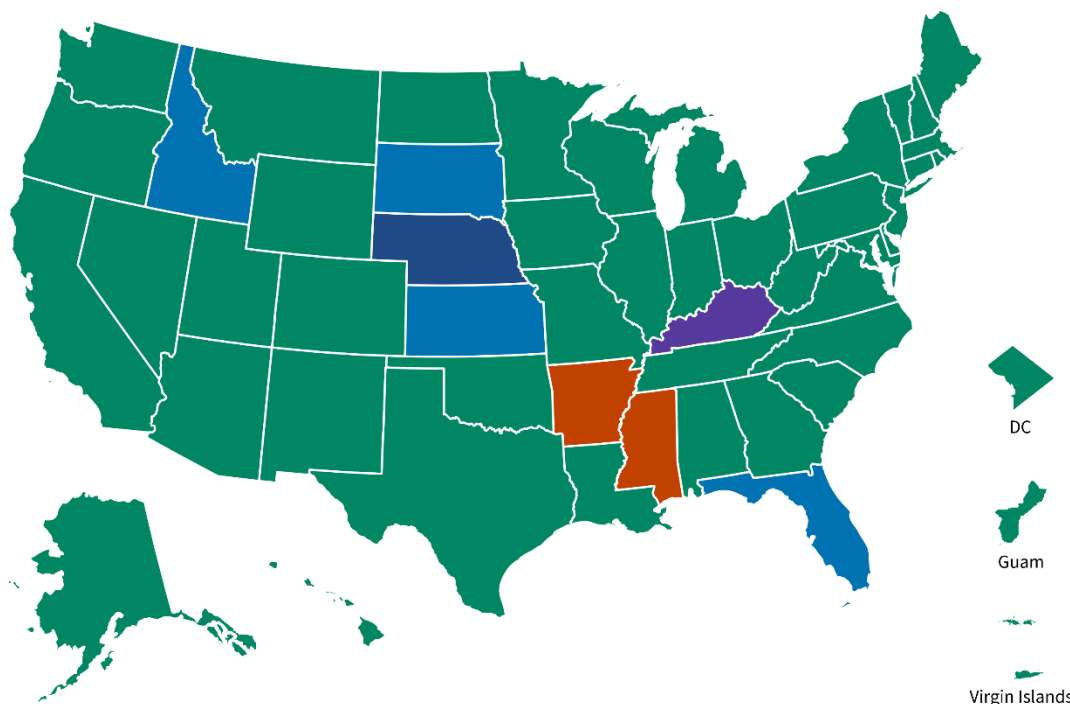
Failure to cooperate: disqualification for noncustodial parent and arrearage on support payments (1)

Comparable Disqualifications

Section 6(i) | 273.11(k)

State agencies may disqualify a household member who fails to perform actions required by certain Federal, State, or local means-tested public assistance programs. State agencies have the option to apply this provision to one or more such programs and may select which disqualifications within a program apply to SNAP recipients. However, SNAP rules set specific limitations. The following are examples of such limitations:

- State agencies may disqualify only the individual who committed the violation, even if the entire household was disqualified under the rules of the other program.
- State agencies may not disqualify an individual for failing to perform a purely procedural requirement.
- State agencies may not disqualify an individual who is not receiving SNAP, including applicants for SNAP.

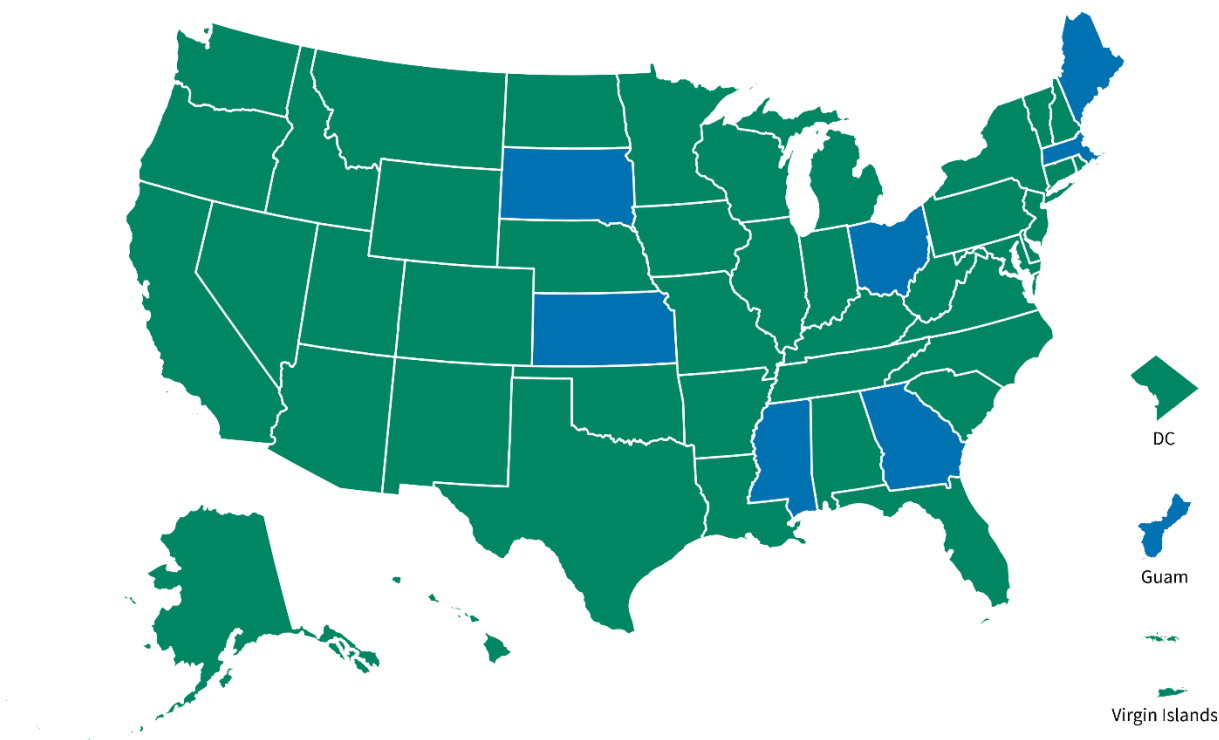

Drug Felony Disqualifications

PRWORA Section 115 | 273.11(m)

Federal law permanently disqualifies household members convicted of a Federal or State felony offense involving the possession, use, or distribution of a controlled substance after August 22, 1996. However, Federal law allows State legislatures to opt out of the disqualification or modify the disqualification to impose a less severe restriction. The following are examples of modified disqualifications:

- Limit the circumstances in which the permanent disqualification applies (such as only when convictions involve the sale of drugs).
- Require the convicted individual to comply with the terms of their parole.
- Require the convicted individual to pass drug testing.
- Require the convicted individual to participate in a drug treatment program.

This information reflects laws enacted by State legislatures and the absence of such laws.

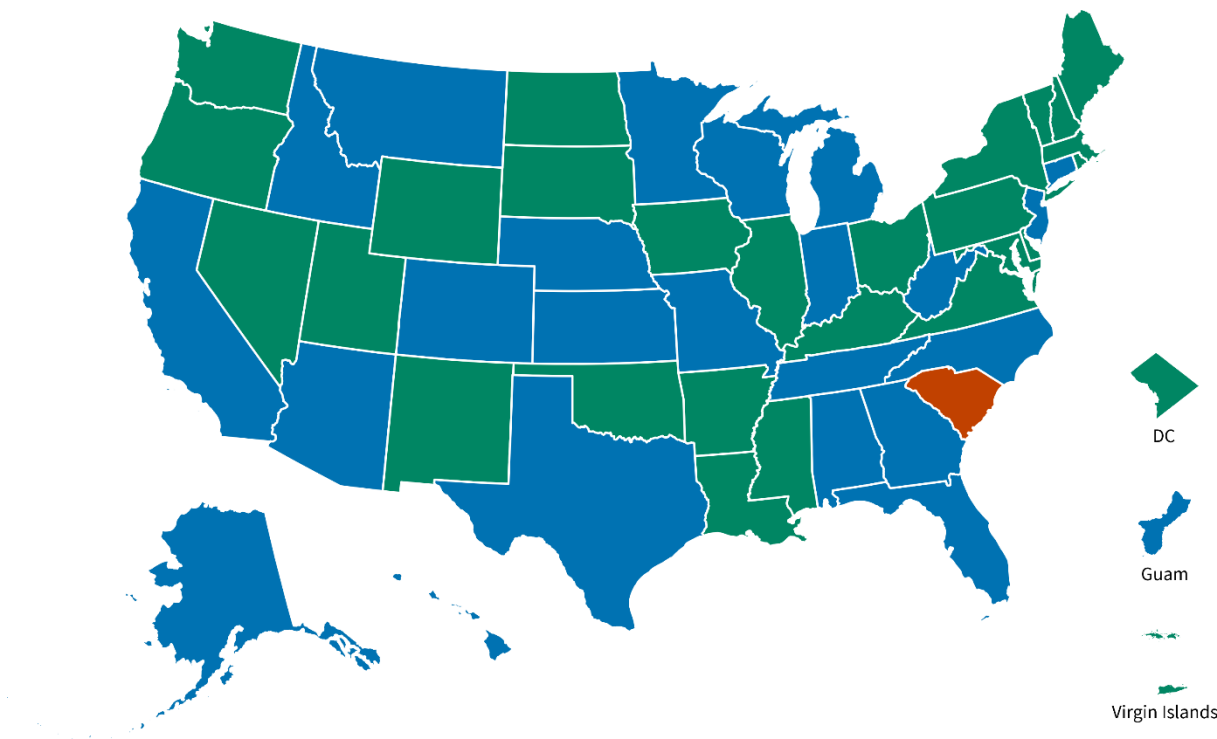

Section 16(h)(1)(E) | 273.7(d)(3)

State agencies can commit (or pledge) to offer all at-risk ABAWDs participation in a qualifying work program or workfare program that fulfills the ABAWD work requirement, including but not limited to SNAP Employment and Training. An at-risk ABAWD is a SNAP household member who is:

- in the last month of their 3-month ABAWD time limit,
- not exempt from the ABAWD work requirement,
- not exempt as a result of receiving an ABAWD discretionary exemption, and
- not residing in an area of the State covered by an ABAWD time limit waiver.

State agencies that pledge to serve all at-risk ABAWDs receive additional funding.

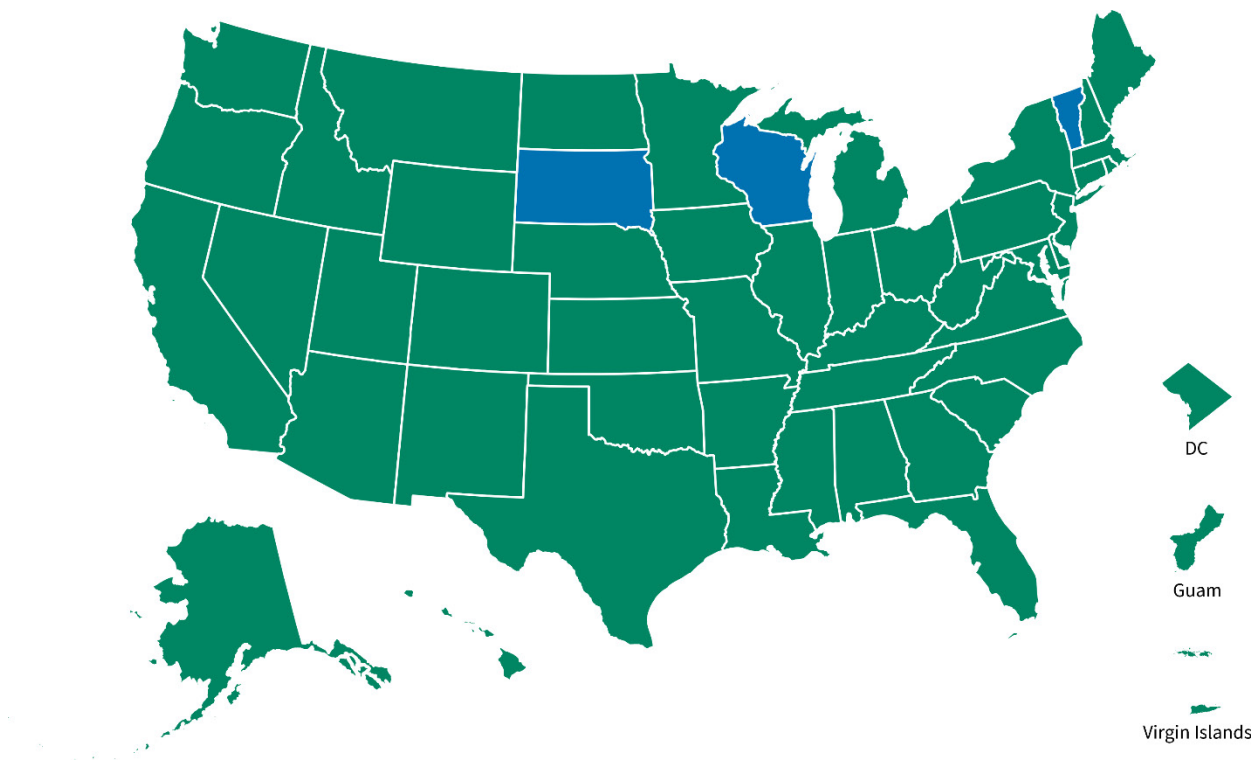

Program Administration

Section 3(s) | Section 11(d) | 271.2 “State agency” | 272.2(c)(2)(ii)

State agencies have the flexibility to adapt their organizational structure to administer SNAP according to their unique circumstances and the needs of their residents. State agencies may opt to centralize or decentralize their administration of SNAP. For example, State agencies may choose to administer SNAP at the State level or at the regional, district, or county level.

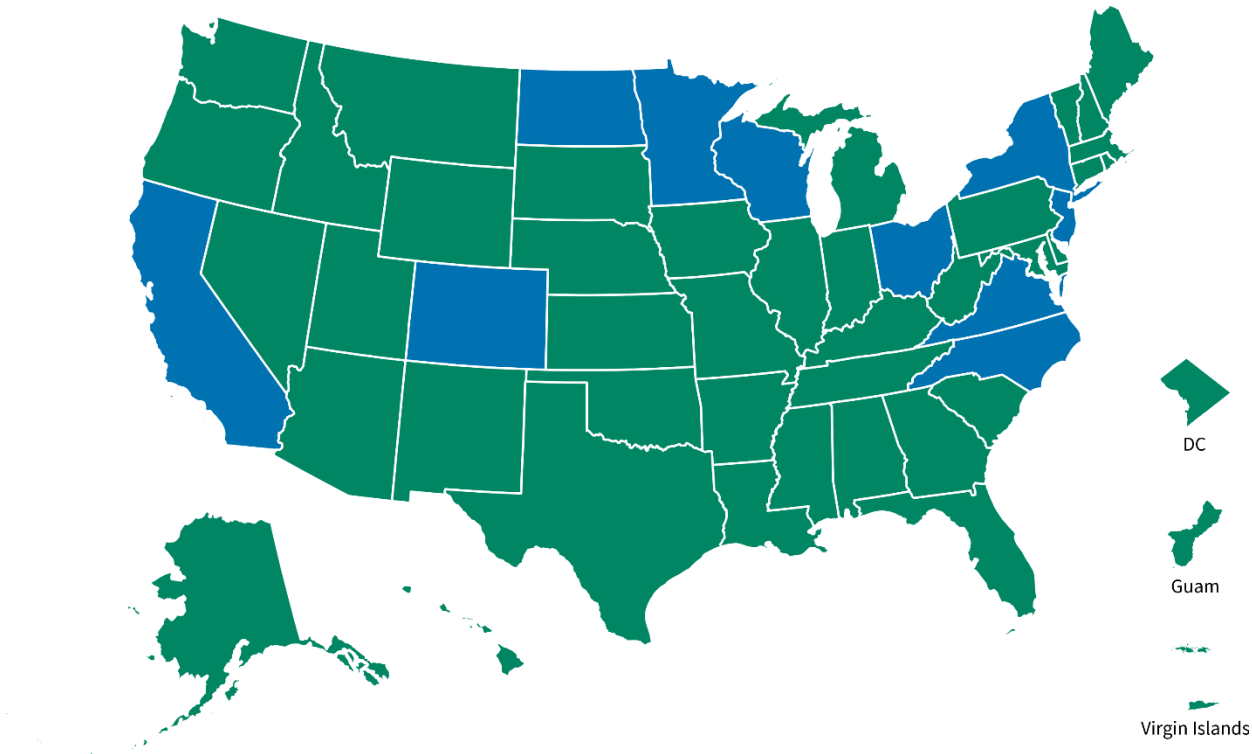

Reporting Requirements

Section 6(c)(1)–(3) | 273.12(a) | 273.21

State agencies must assign SNAP households to one of the reporting systems offered by Federal rules. The type of reporting system dictates the specific changes in circumstances the households must report to the State agency and when. Some State agencies assign different reporting systems according to household circumstances. Households assigned to change reporting must report certain changes in circumstances within 10 days of the date the change occurs or within 10 days before or after the end of the month in which the change occurs. Households assigned to simplified reporting must report changes periodically and when total countable income rises above 130 percent of the Federal poverty level, when work hours for able-bodied adults without dependents (ABAWDs) fall below 20 hours per week, or when a household receives substantial lottery or gambling winnings.

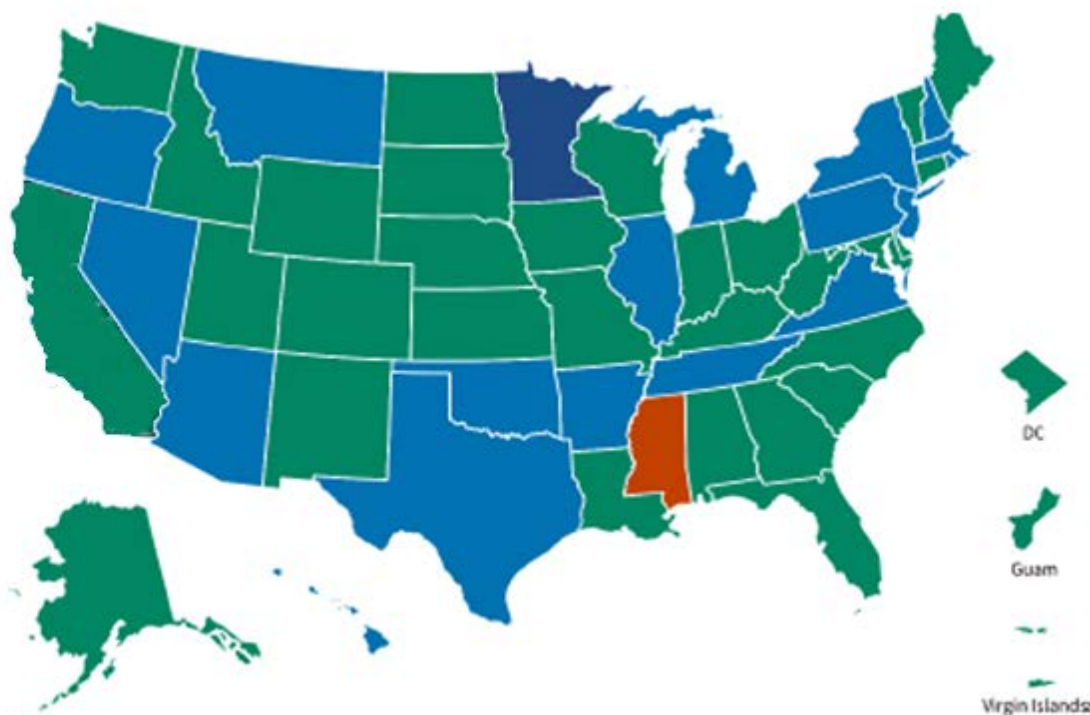

Transitional Benefits Alternative

Section 11(s) | 273.26

State agencies have the option to offer transitional benefits alternative (TBA) SNAP benefits to households leaving TANF or households with children leaving State-funded cash assistance programs. TBA provides households with a set benefit amount and eliminates reporting requirements during the transition period. Benefits can be continued for up to 5 months at a level equal to the amount the household received before TANF termination, with adjustments for the loss of TANF income. Certification periods may be extended for households to receive the full 5 months of benefits. State agencies may exclude from TBA households in which all members are ineligible to receive SNAP benefits for the following reasons:

- They fail to comply with laws related to a means-tested program.
- They fail to cooperate with child support agencies.
- They are delinquent in court-ordered child support.

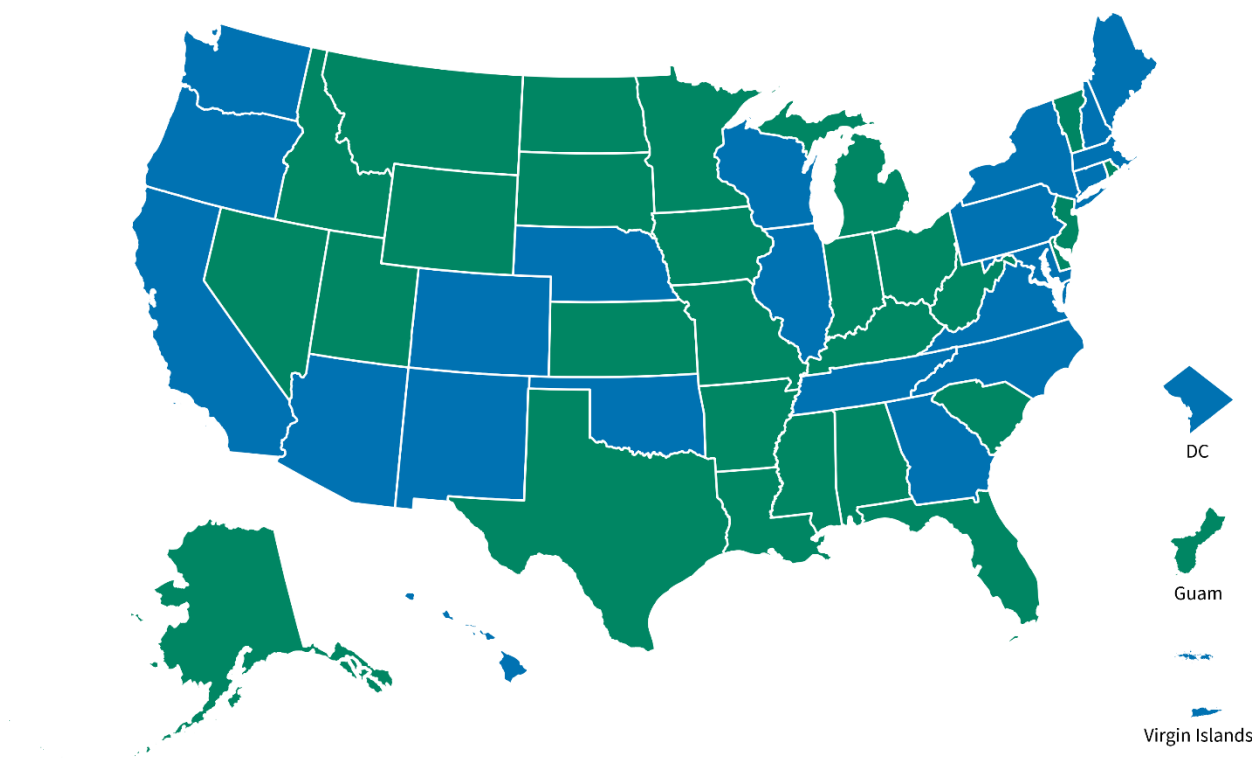

Child support income expense deduction (39)

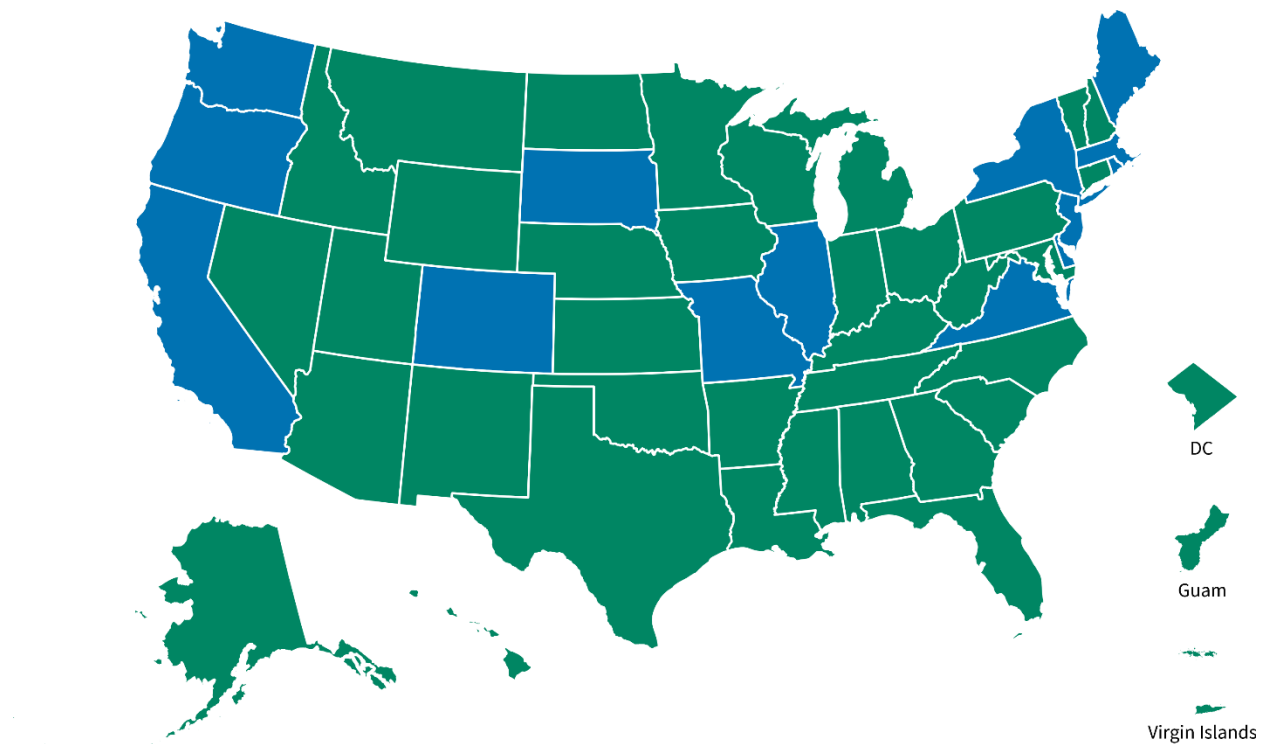

Section 5(e)(6)(C) | 273.9(d)(6)(iii)

Revised

When determining a household's eligibility and benefit amount for SNAP, State agencies consider households' total shelter costs, including the cost of utilities. State agencies can use Standard Utility Allowances (SUAs) in place of households' actual utility costs when determining total shelter costs. State agencies can opt to make their SUAs mandatory for households that qualify for them. State agencies using this option must not prorate SUAs for households that share living space and heating or cooling expenses. State agencies that do not opt to make their SUAs mandatory must allow households to claim actual utility expenses.

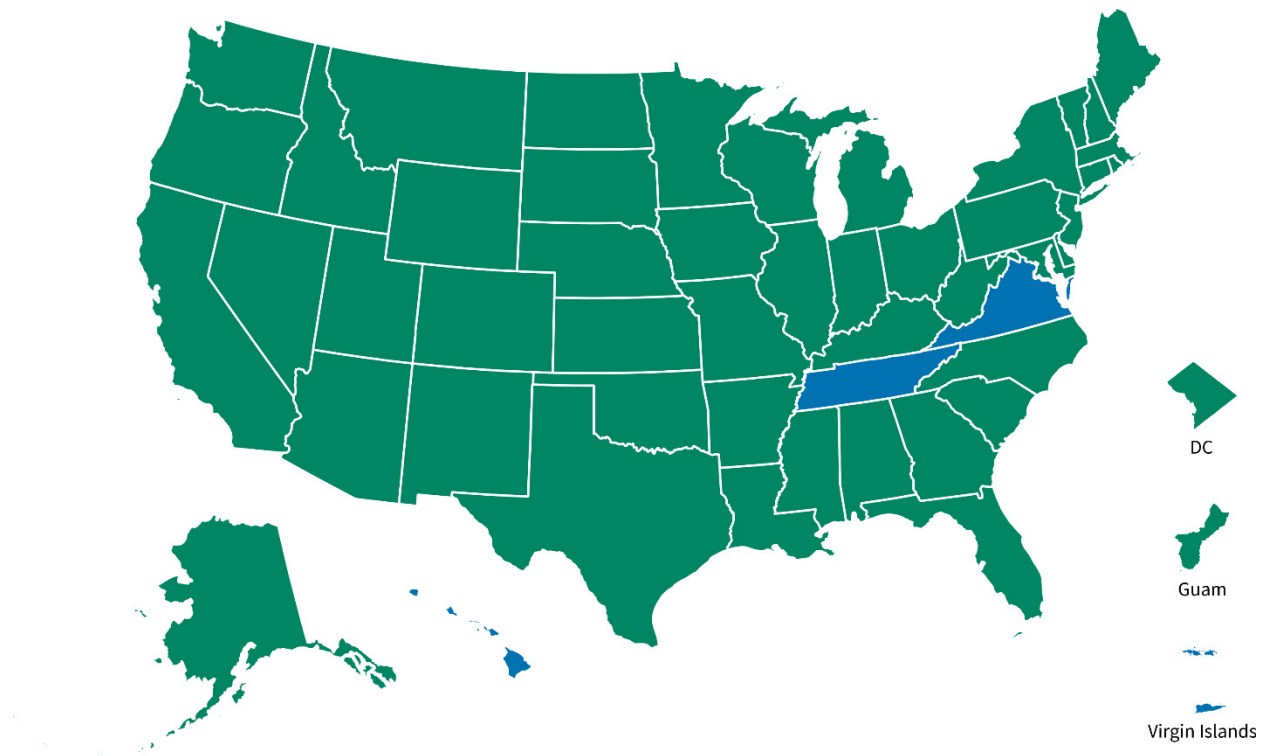

Voluntary and Mandatory SNAP Employment and Training Programs

Section 6(d)(4)(G) | 273.7(e)(5)(i)

State agencies are required to operate SNAP E&T programs. However, State agencies have significant flexibility in the types of programs they offer and the types of SNAP participants they serve. State agencies take one of the following options:

- offer SNAP E&T to certain household members on a voluntary basis,
- mandate that certain household members participate in SNAP E&T to maintain SNAP eligibility (as allowed by the SNAP general work requirements) and offer voluntary participation to others, or
- mandate that certain household members participate in SNAP E&T to maintain their SNAP eligibility (as allowed by the SNAP general work requirements) without offering voluntary participation to others.

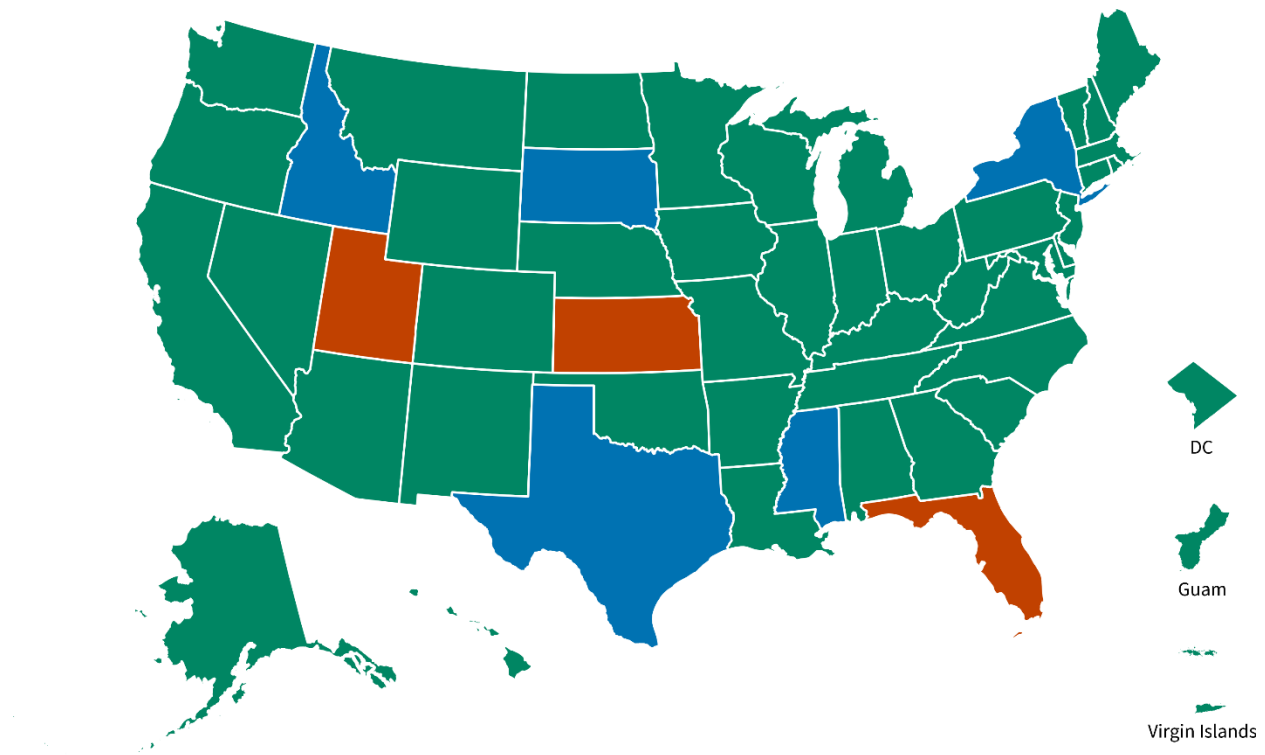

Work Requirements: Disqualification Period Policy

Section 6(d)(1)(C) | 273.7(f)(2)

SNAP household members aged 16–59 must comply with the SNAP general work requirements, which include work registration and a requirement to accept a suitable job if offered, restrictions on voluntarily quitting a job or decreasing hours, and potentially mandatory participation in SNAP Employment and Training (E&T) or workfare. People are exempt from the general work requirements if they are facing physical or mental barriers to work, caring for a young child or incapacitated person, employed at least 30 hours, or participating in school or a training program half-time or more.

Nonexempt individuals who fail to comply, without good cause, are disqualified until they comply for a minimum of 1 month for the first instance, 3 months for the second, and 6 months for the third. State agencies have the option to establish extended disqualification periods of up to 3 months for the first instance, up to 6 months for the second, and a date set by the State agency or permanently for the third.

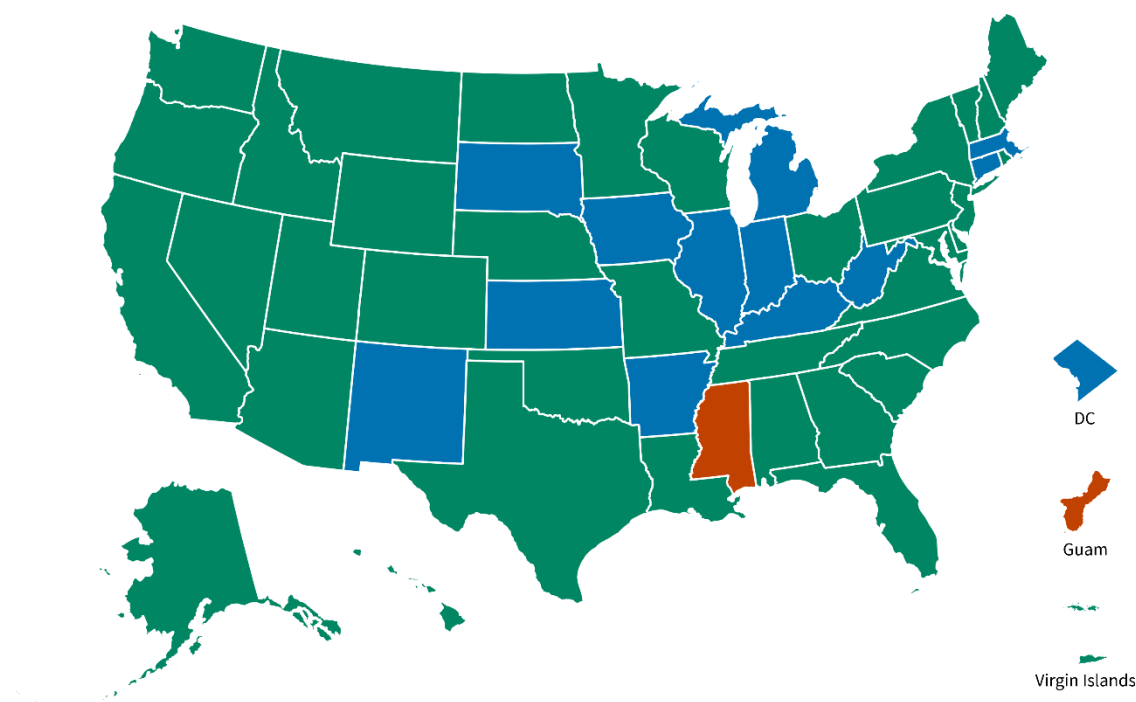

People are exempt from the general work requirements if they are facing physical or mental barriers to work, caring for a young child or incapacitated person, employed at least 30 hours, or participating in school or a training program half-time or more.

Nonexempt individuals who fail to comply, without good cause, are disqualified (see SNAP Option Profile *Work Requirements: Disqualification Period Policy*). State agencies have the option to disqualify the entire household if the household member who failed to comply is the designated head of household.

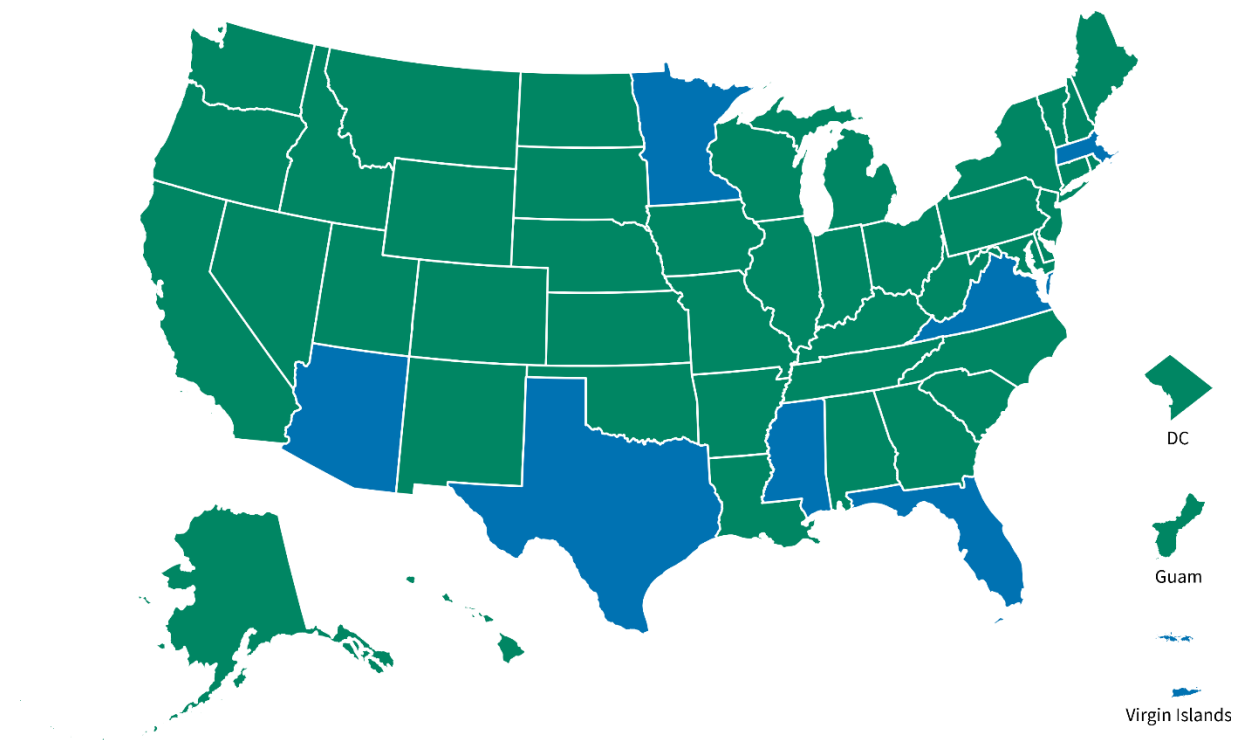

Demonstration Projects

State agencies can request approval from FNS to conduct demonstration projects that improve program administration, increase the self-sufficiency of SNAP recipients, test innovative strategies, or allow greater conformity with the rules of other programs. FNS's statutory authority to approve demonstration projects requires that projects include an evaluation component.

This section highlights several demonstration projects State agencies may request to implement.

Combined Application Projects

Section 17(b)(1)(A)

Combined Application Projects (CAPs) are SNAP demonstration projects that involve collaboration among the Social Security Administration (SSA), FNS, and State and local agencies to streamline application procedures for individuals also receiving SSI benefits. CAPs are available in two models: standard and modified. The standard model includes simplified joint SNAP/SSI application processing by SSA as individuals apply for or are recertified for SSI. The modified model uses data from SSA to send eligible SSI households simplified SNAP applications. Most CAPs use standard SNAP benefit amounts and/or shelter expenses in the benefit calculation.

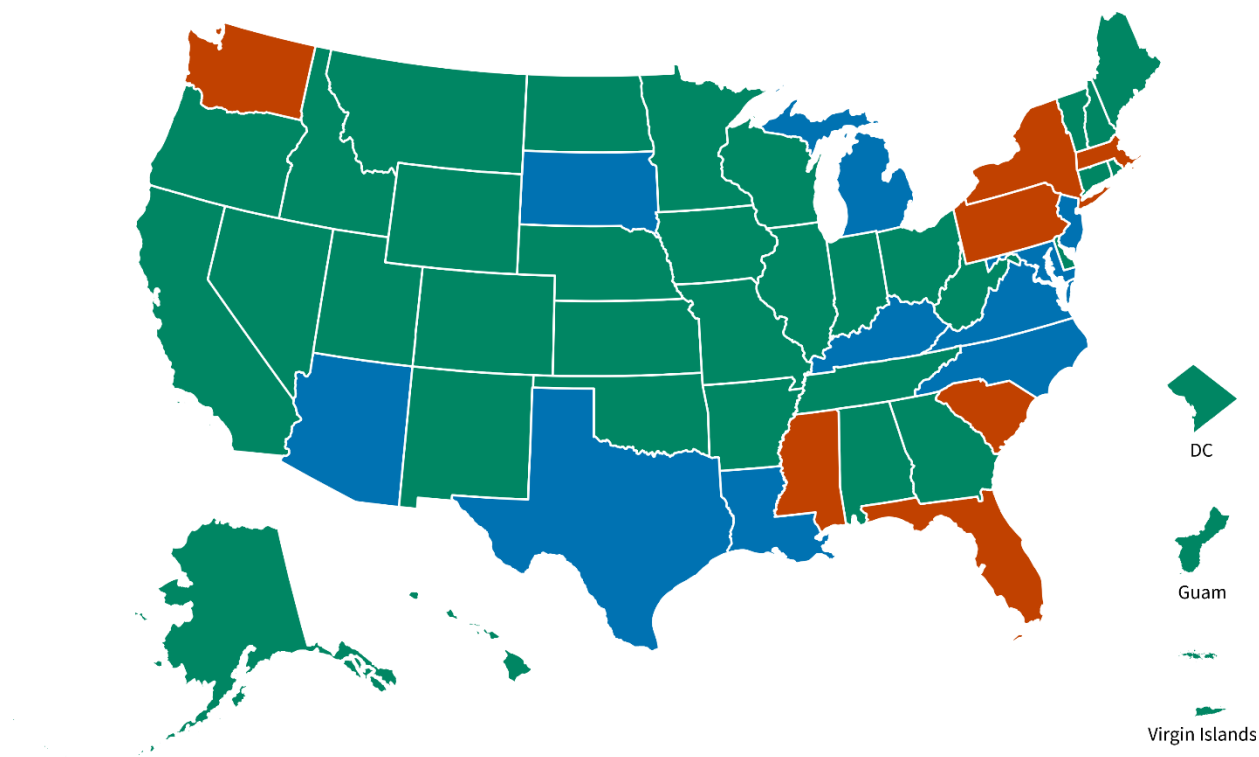

The Elderly Simplified Application Project (ESAP) is a SNAP demonstration project focused on households with adults aged 60 or older and people with disabilities. ESAP streamlines the application and certification process by simplifying the verification process, providing 36-month certifications, and waiving the recertification interview. ESAP serves households that do not have earned income and in which all adult members are aged 60 or older and/or have a disability.

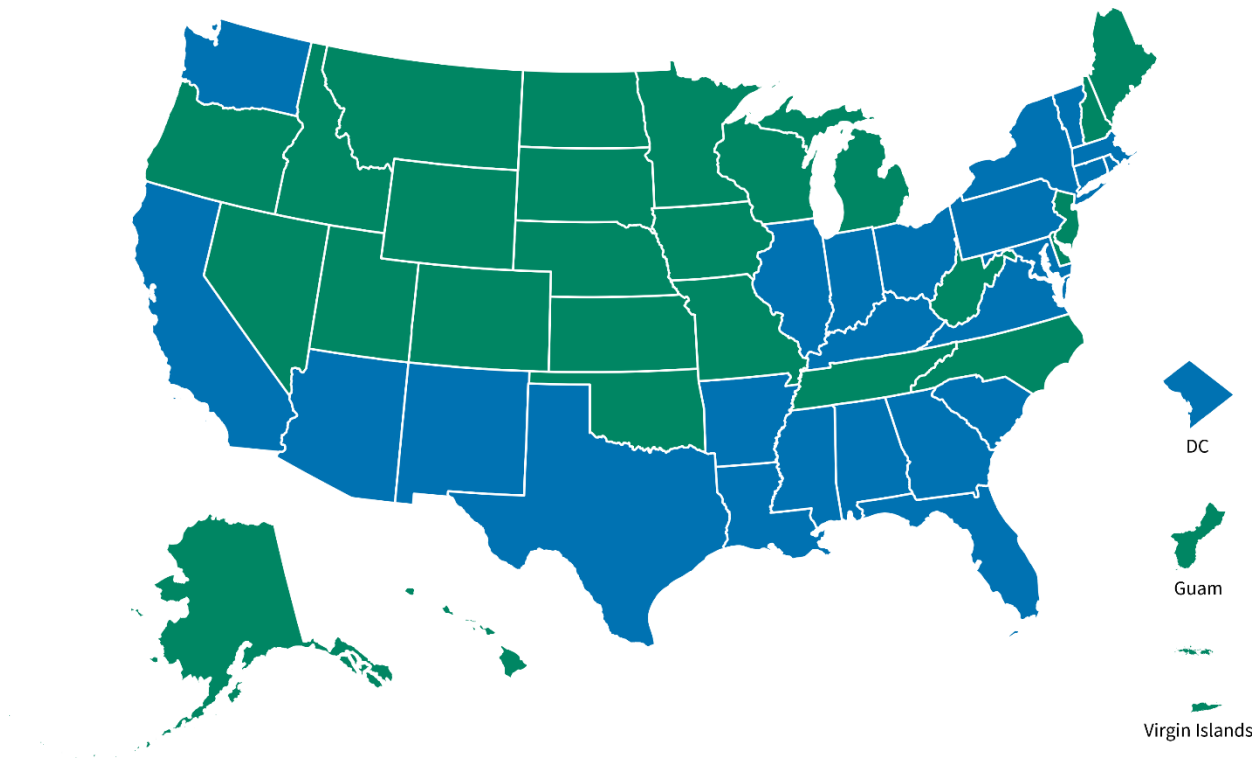

Standard Medical Deduction Project

Section 17(b)(1)(A)

The Standard Medical Deduction (SMD) is a SNAP demonstration project focused on households with adults aged 60 or older and people with disabilities. SMD simplifies the excess medical expense deduction by allowing State agencies to establish a standard deduction amount for certain households. SNAP households with an adult aged 60 or older and/or a person with a disability are entitled to a deduction from their household income of allowable, out-of-pocket medical expenses those individuals incurred over \$35 a month. The SMD allows agencies to streamline administrative procedures, reduce the paperwork burden on older adults and individuals with disabilities, and simplify the process of claiming this deduction. Households may opt to claim actual medical expenses if they are greater than the SMD.

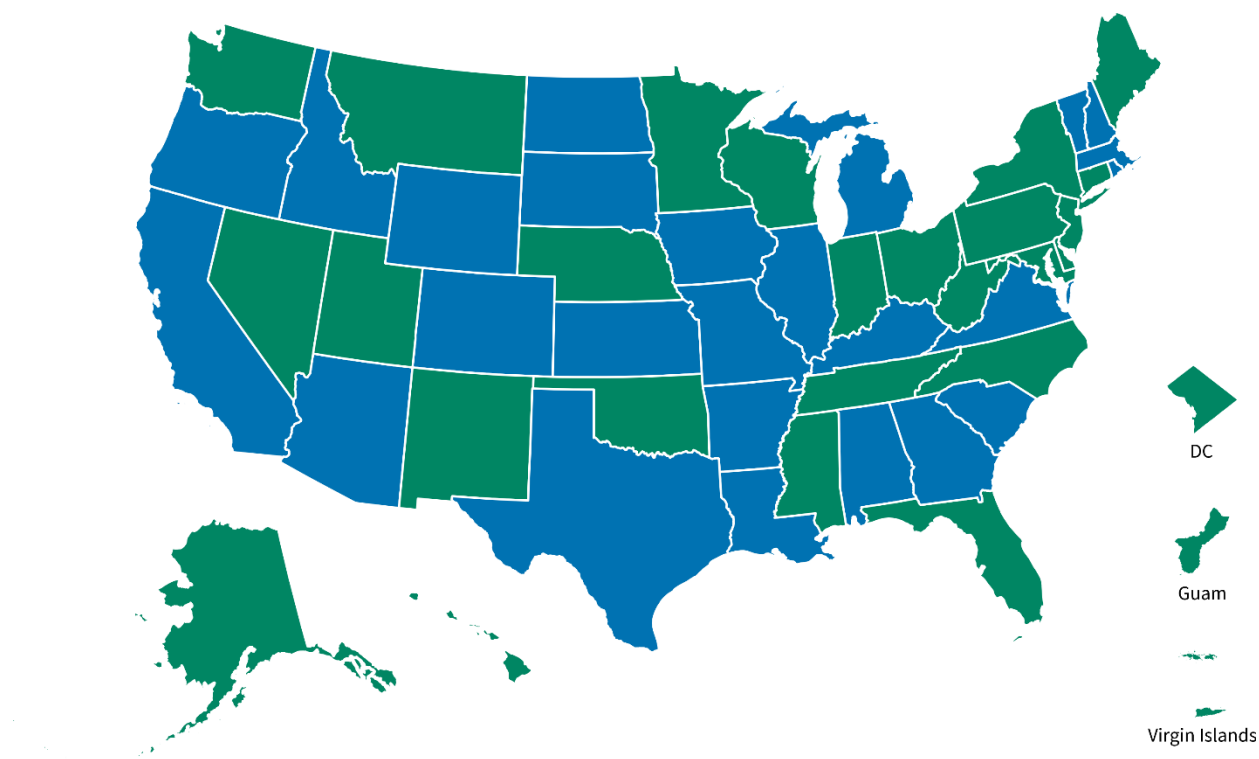

Waivers

State agencies may request approval from FNS to waive specific regulatory requirements to enhance the efficiency and effectiveness of program administration and better address the needs of eligible households in their jurisdictions. State agencies may also request to temporarily waive the statutory time limit and work requirement for ABAWDs.

This section highlights commonly requested waivers that affect the SNAP application and eligibility determination processes.

ABAWD Time Limit Waiver

Section 6(o)(4)(A) | 273.24(f)

An ABAWD is a person aged 18–54 who does not meet any of the exemption criteria set by Federal law. A person is not considered an ABAWD if they are exempt from the SNAP general work requirements, share a household with a person younger than 18, are pregnant, are experiencing homelessness, are a veteran, or are younger than 25 *and* were in foster care at 18 (or a higher age if the State offers extended foster care). In addition to the SNAP general work requirements, ABAWDs must work and/or participate in a work program at least 80 hours per month or participate in workfare to receive SNAP benefits for more than 3 months in a 3-year period. State agencies have the option to request a waiver of this restriction in areas with an unemployment rate above 10 percent or a lack of sufficient jobs. FNS generally approves waivers for a 12-month period. Implementation periods are not required to align with the Federal fiscal year or quarter, and State agencies may choose to discontinue a waiver prior to its expiration. An ABAWD time limit waiver does not waive the SNAP general work requirements.

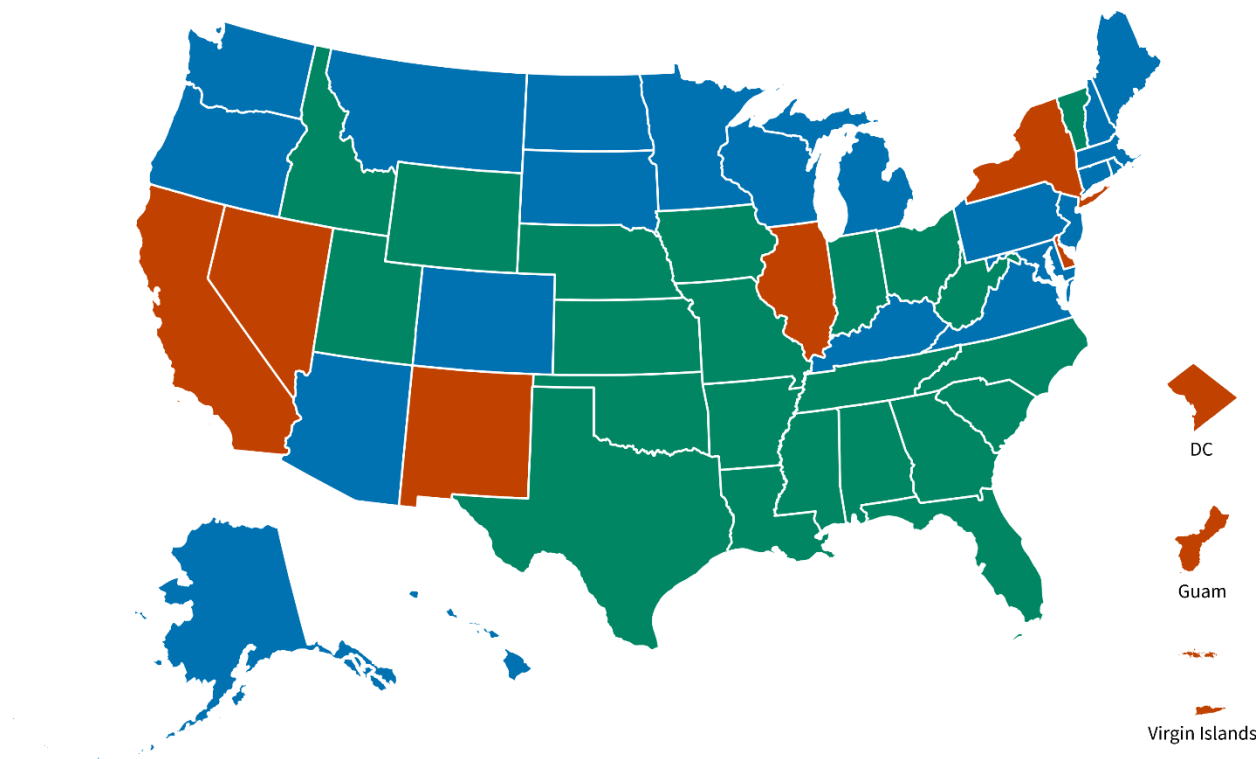

Alter Procedures When Change of Address Is Reported Waiver

272.3(c)

New

Under regular SNAP rules, when State agencies receive a verified change in address for a household during the certification period but do not receive a corresponding update to the household’s shelter costs, State agencies must send a notice to households asking for updated shelter costs. If the household does not provide updated shelter costs within 10 days, the State agency will recalculate the household’s SNAP benefit allotment without the shelter deduction. State agencies have the option of requesting a waiver of the requirement to recalculate the allotment without the deduction if the household does not respond. This allows the State agency to continue to provide the deduction to the household rather than remove it based on lack of response alone. Under the waiver, the State agency must follow up on unreported shelter cost changes at the next recertification or periodic report, whichever is sooner.

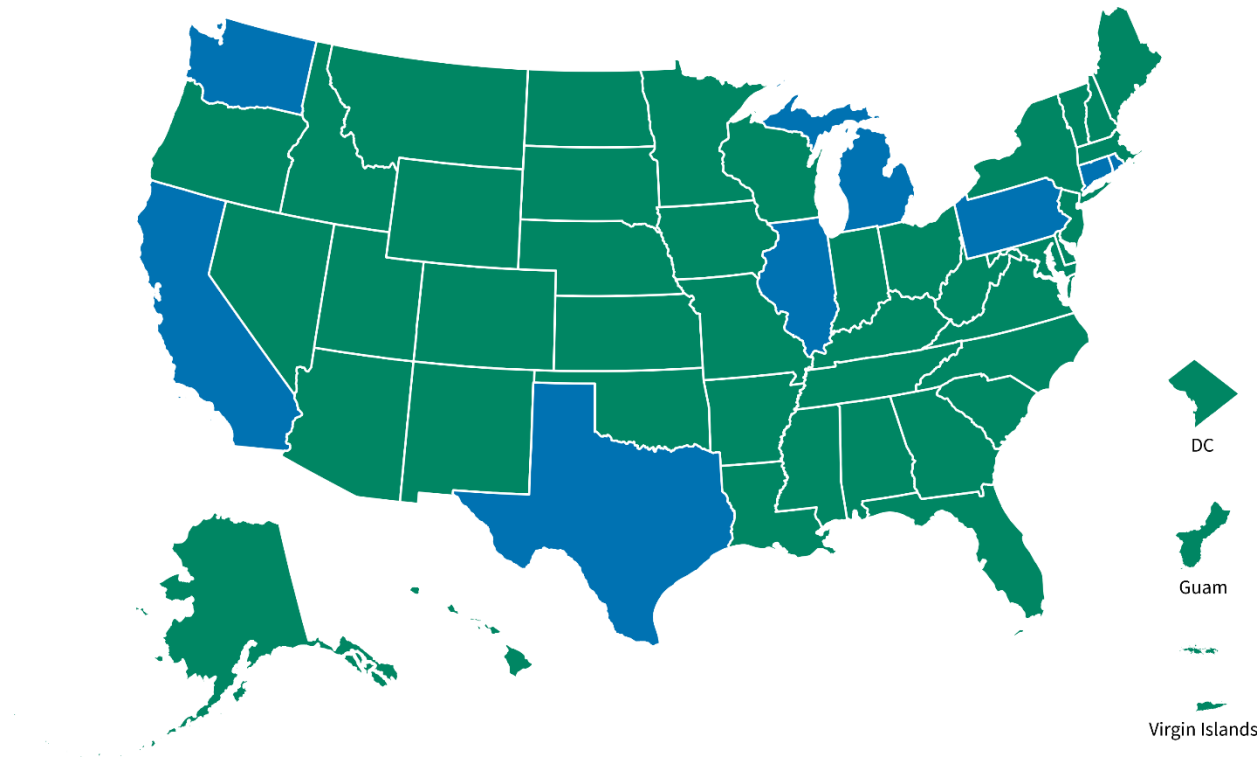

Conduct Unscheduled Interviews (On Demand) Waiver

272.3(c)

New

Under regular SNAP rules, State agencies must schedule an interview for all applicant households that are not interviewed the day they submit their applications. State agencies have the option of requesting a waiver to forgo the interview scheduling requirement. The waiver allows State agencies to give households the option to complete a telephone interview within a specified time period (date range within the State agency's business hours) at the household's convenience. To effectively implement the waiver, the State agency must have sufficient resources and staff to promptly handle all calls for interviews during the specified time period. Without these capacities, the waiver would be ineffective and could worsen customer service.

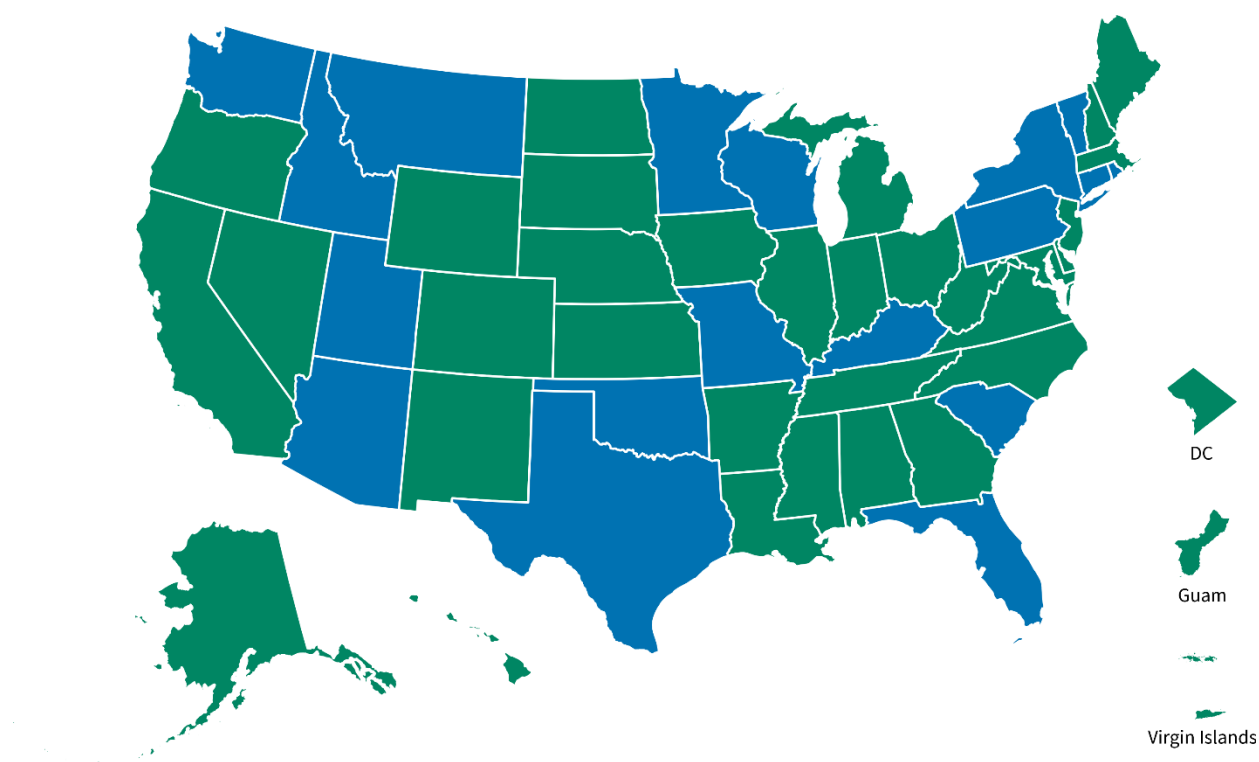

Deny Applications Before the 30th Day (Early Denial) Waiver

272.3(c)

New

Under regular SNAP rules, State agencies must allow households 30 days after the application filing date to provide verification before denying the household’s application. State agencies have the option of requesting a waiver of the 30-day requirement. Under the waiver, State agencies may deny an application if the household does not provide required verification. Before denying an application under the waiver, the State agency must have conducted an interview with the household and provided at least 10 days to return the required verification. If the household returns the required verification within 60 days of the application date, the State agency must act on the verification without requiring a new application and determine eligibility and benefits under regular SNAP rules. State agencies adopt this waiver to make eligibility determinations more efficiently for households that ultimately may be unlikely to provide required verification.

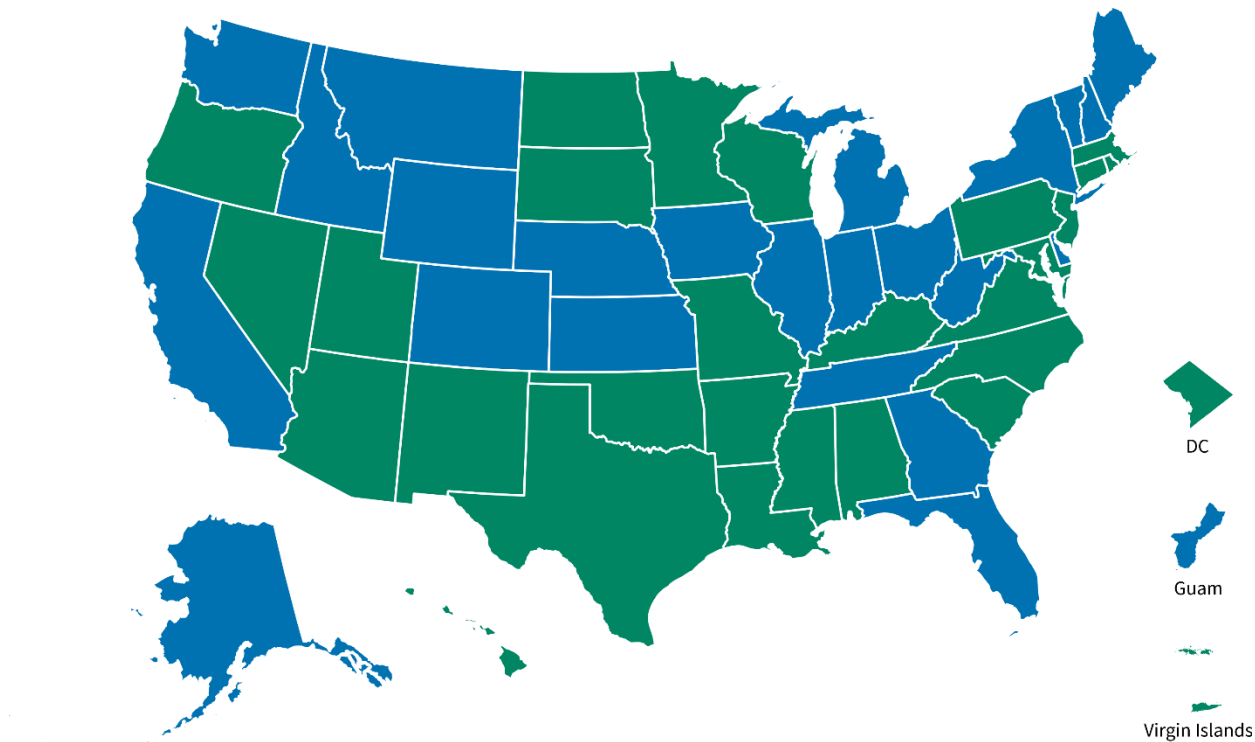

However, State agencies have the option of requesting a waiver to provide benefits to eligible individuals as of their release date from the institution. The waiver allows State agencies to:

- accept applications from individuals who are residents of institutions nearing their release date,
- process the application to a determination before the individual's release date, and
- issue benefits to eligible individuals upon release from the institution.

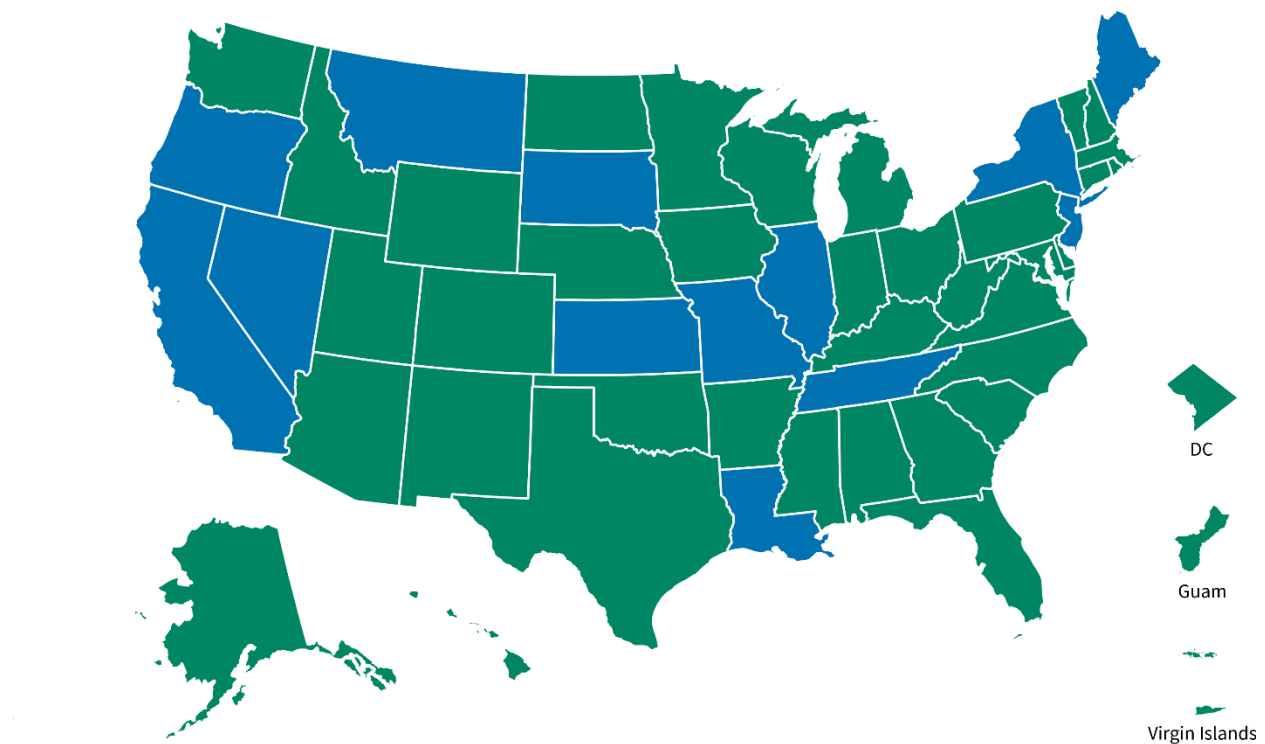

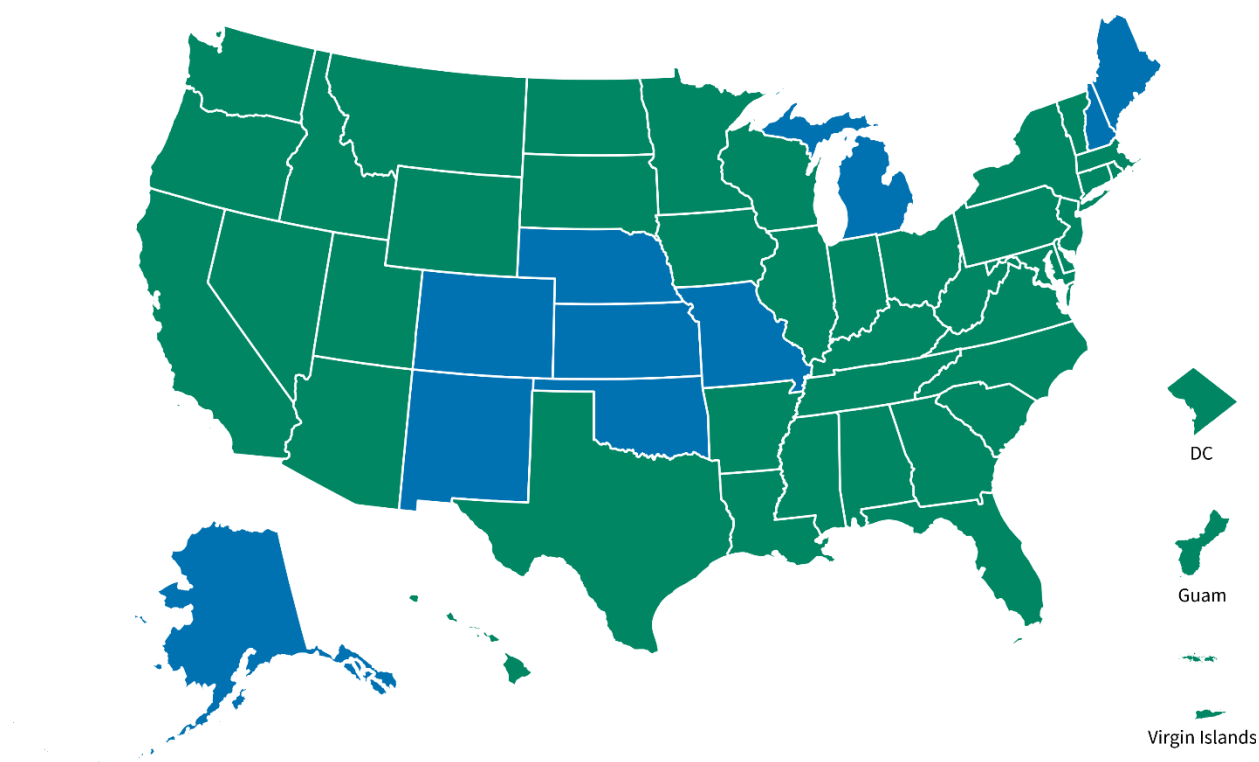

Reinstate Eligibility (Reinstatement) Waiver

Under regular SNAP rules, State agencies must terminate households if they do not provide the required information and verification the State agency requests during the certification period. Terminated households that wish to continue receiving SNAP must submit a new application. State agencies have the option of requesting a waiver to allow recently terminated households to regain eligibility without submitting a new application. Under the waiver, households can reestablish eligibility if they provide the missing information within 30 days from their termination date. The State agency must prorate benefits from the date eligibility is established and maintain the household's certification period.

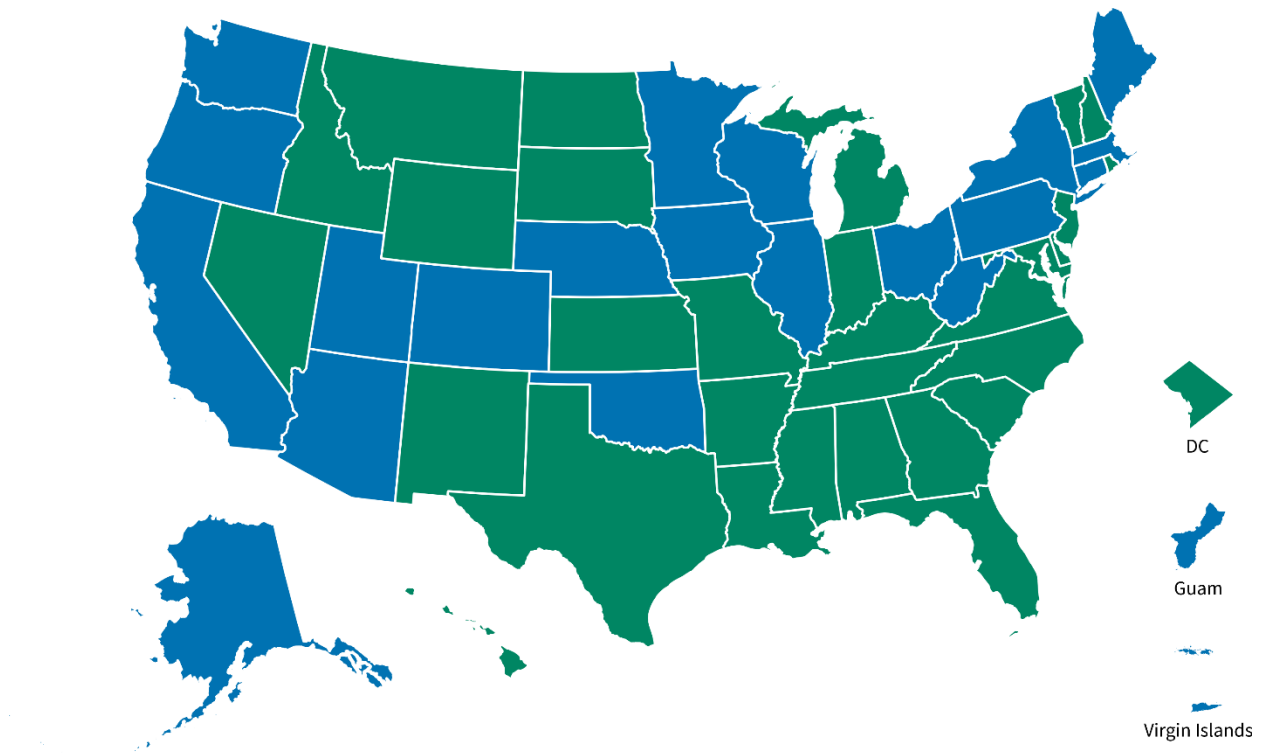

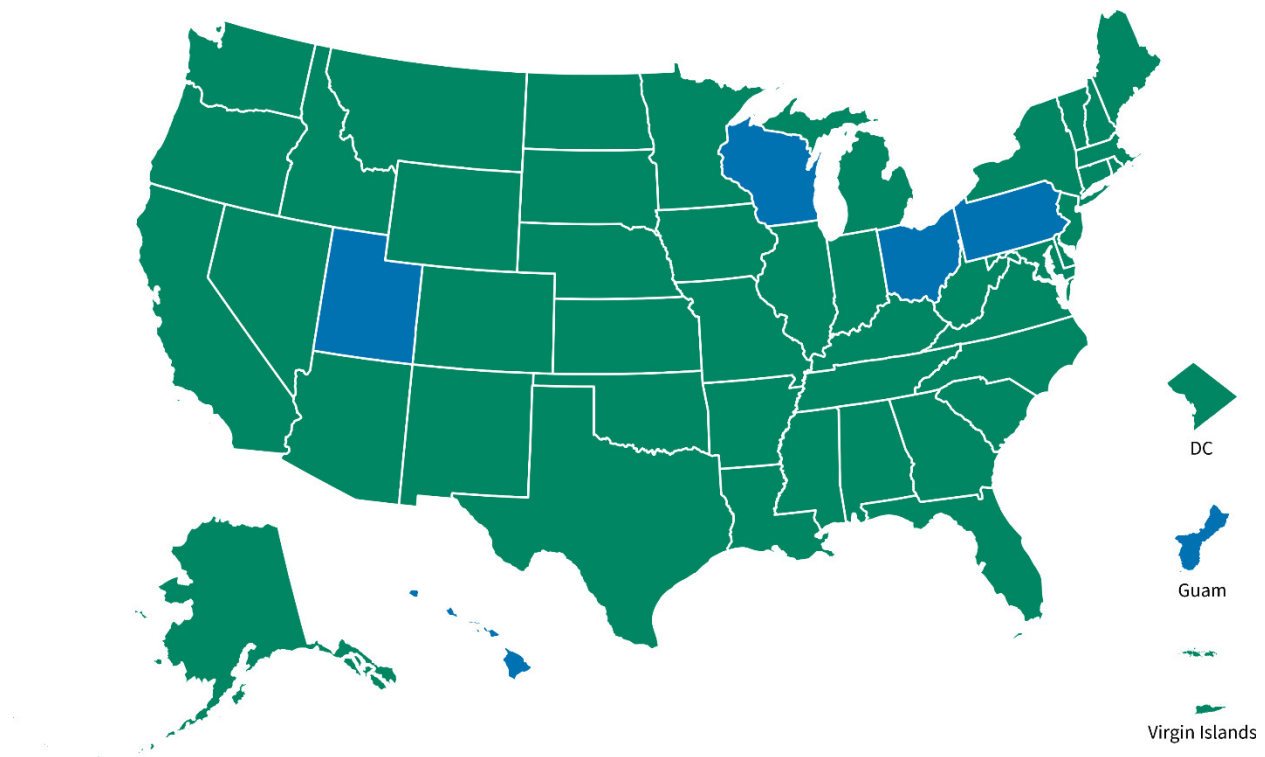

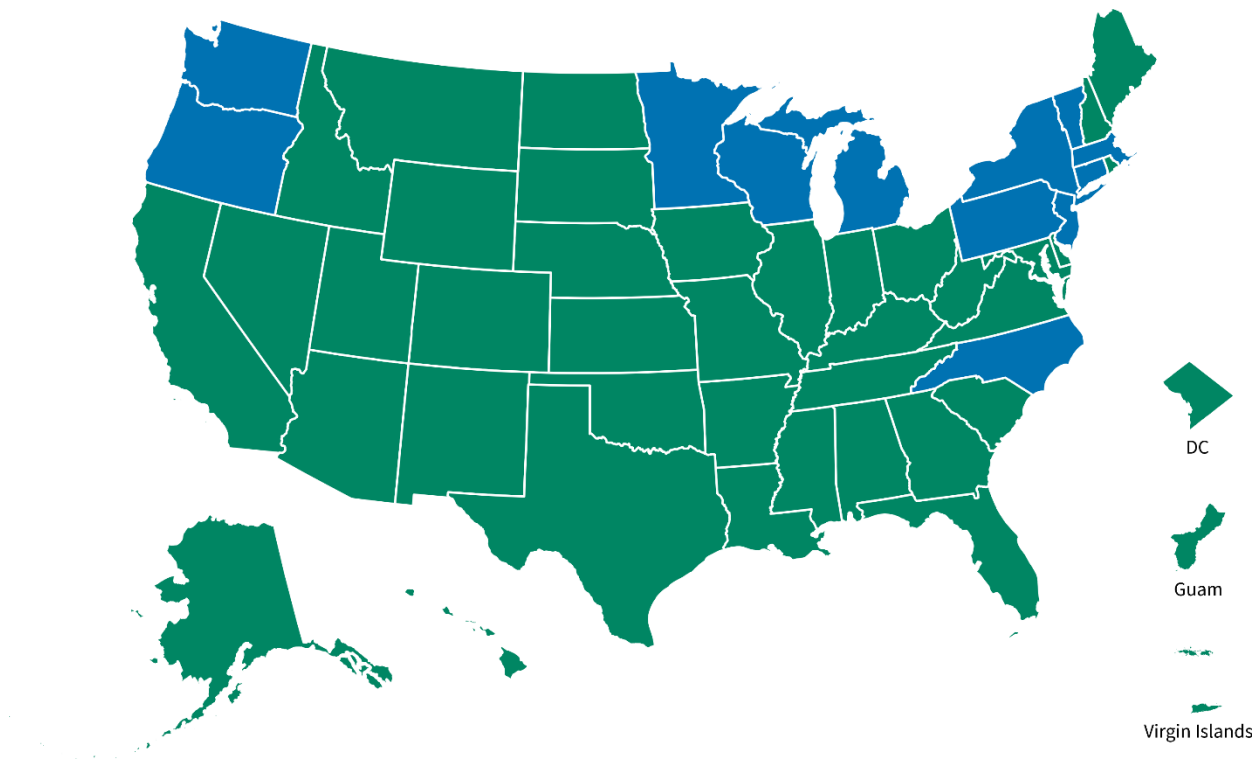

Under regular SNAP rules, State agencies that choose to accept telephonic signatures are required to make an audio recording of the household’s verbal approval of the household’s information on the application. This recording must be linked to the SNAP application. State agencies have the option of requesting a waiver of the audio recording of the household verbal approval. Under the waiver, State agencies must document the verbal approval in the case file and provide the applicant a written copy of the complete application.

State agencies are required to send SNAP households notices to request information or inform the household of actions taken on their case. Traditionally, State agencies have sent notices by mail. Now, many State agencies enable households to view these notices electronically after logging in to their online account. State agencies notify households by email that a notice is ready to be viewed online. State agencies can also send a text message in addition to an email. However, sending a text message alone (to notify the household that a notice is ready to be viewed online) is not allowed without this waiver approval. State agencies must allow households to opt in or out of receiving electronic notifications at any time.

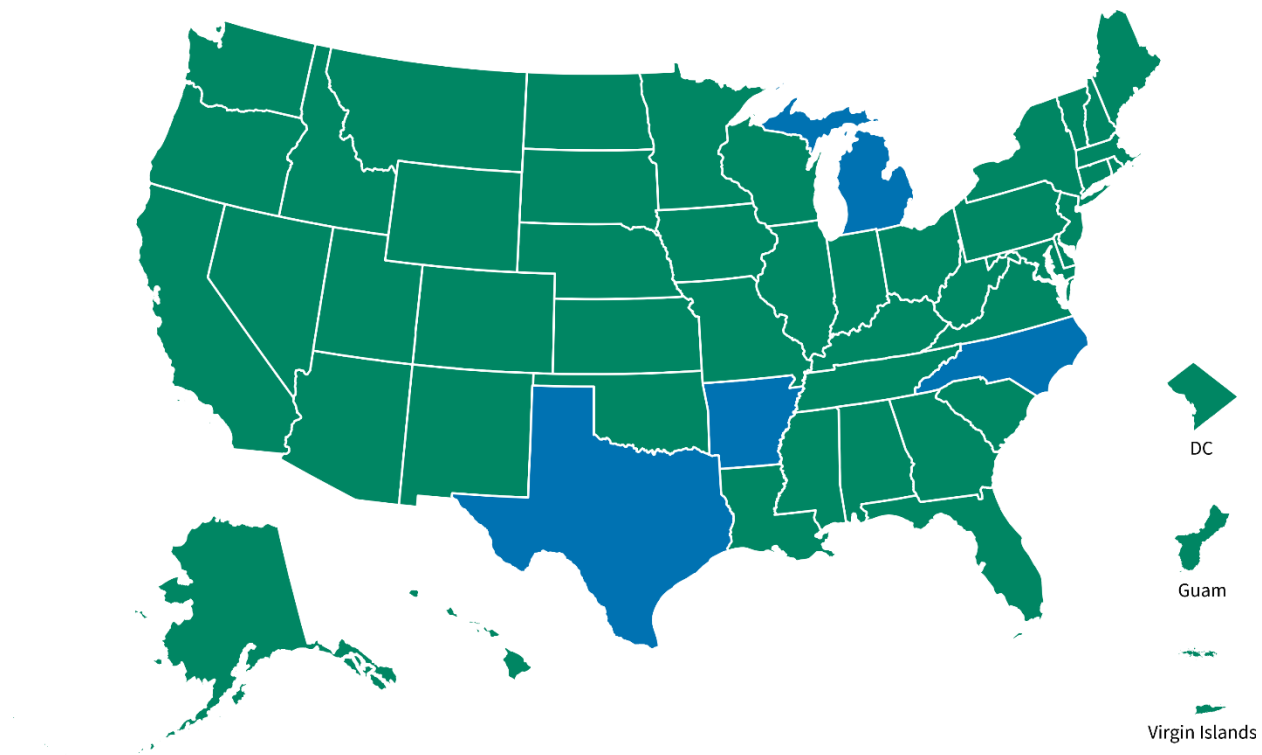
